Regarding Questionnaire 10 of N.A. World Services Inventory, our area would like to confirm on (A).

- (A) Our service is having problems regarding sending contributions to world services --
- i) Indian currency and U.S. currency differs a lot (Exchange value = \$1 = Rs.30).
 - ii) Our recovering strength is progressing. But individual contribution to the groups or to A.S.C. is meagre due to the following conditions --
 - a) Most of the recovering addicts are students (below 30 yrs) or unemployed youths.
 - b) Most of the addicts comes from the middle class or middle lower class groups.

So our area is functioning under limited financial support and under this condition our area is unable to contribute regularly to the world service.

So regarding your questionnaire 10(A) we're confuse. Are we supporting the world services or are we not supporting it as we're unable to send regular contribution ?

Regarding Questionnaire 15(A) we would like to share some points:

- a) Currency value between India & U.S. differs a lot (\$1 = Rs.30).
- b) Most of the recovering addicts are students (below 30 years) and unemployed youths.
- c) Most of the recovering or suffering addicts comes from the middle or middle lower class.

So, what we would like to share is that in U.S. the N.A. products might be reasonably price but from our point of view the price is a bit high.
