
From Your World Board Going Places...

We continued to discuss the topic of "Atmosphere of Recovery" this fiscal year, along with the topics that came out of the 2004 World Service Conference: "Infrastructure" and "Our Public Image." The latter is a topic that follows up on the information we gathered through the Public Rela-

tions Roundtables. The topic of "Leadership" came later in the year as a result of many of the issues raised during the workshops we attended. The "Atmosphere of Recovery" discussion was continued this year because of its relevance to the ability of our groups to carry NA's message.



The unprecedented growth in Iran and the coming together of NA communities throughout the world via the fellowship development workshops, new projects, and our far-reaching worldwide workshops increased the demand for literature and services. This increased the demand on our Fellowship Services staff, sometimes at an overwhelming rate. It has always, however, been regarded as an honor to be called upon to meet these crucial needs.

During the last fiscal year, NAWS-Chatsworth printed the Basic Text in Brazilian Portuguese. NAWS-Chatsworth also contracted to have keytags produced in India for distribution there. The challenge of participating in the growth of NA communities and translating NA literature into as many as twenty-five languages has always been met with dedicated commitment by staff. We are proud of their tireless efforts and success in meeting these demands.

AWS-Canada, near Toronto, has a small but devoted staff managing its literature warehouse. The increase of sales in recent years to local NA groups is helping to stabilize the office's running expenses. The main function of the facility

is to accommodate the literature needs of the fellowship in Canada. The literature warehouse employs one full-time

and one part-time worker who fulfill all orders at that location.

Fluctuations the exchange rate initiated an agreement in 1994 to "stabilize" the rate, which resulted in NAWS-Chatsworth subsidizing the difference.

Today, however, with the increasing value of the Canadian dollar, this is no longer the situation, and the Canadian facility is now in a better position than ever before to become self-supporting. Canada's operations are online, and communication with them from NAWS-Chatsworth is now on a regular basis via email. Jacquie and Paul, our staff members there, continue to meet the growing literature demands of the Canadian NA community. We are very grateful for their devoted commitment to fulfilling these needs.


vidence of explosive growth in the NA community in Iran was confirmed when two World Board members traveled to Iran to assess their development and discovered more than 30,000 NA members embracing recovery—an unprecedented and very heartfelt surprise for all of us. Some meetings were being held in parks in order to accommodate the number of addicts attending.

Serving the members in Iran who needed recovery material and resources was a challenge due to government, trade, and travel restrictions. When three NA members from Iran were funded to attend the Middle Eastern workshop, held in Bahrain in February 2005, we began talking about how we could assist. After careful consideration, we concluded that the most effective solution was to open a literature production and distribution center in Iran.

Siamak, who now manages this location, coordinated the establishment of the facility, which was opened in June 2005. We are very

NAWS opened its fourth office in June 2005. Prior to our decision to open this office, we were stymied by the challenge of how to help meet the needs of more than 30,000 members in this community.

Today, Iran continues to experience unprecedented recovery growth—meetings are often held in parks to accommodate the vast numbers of addicts in recovery. We are told that there are instances where a sponsor has one hundred or more sponsees. We all extend our heartfelt welcome and support to our brothers and sisters in Iran.


Conventions and Events


NAWS conventions and events management includes a number of annual and biennial projects, which all require simultaneous attention. The World Convention of Narcotics Anonymous (WCNA) and logistical planning for the World Service Conference (WSC) are the two major events; however, we also participate in worldwide workshop planning and coordinate overall travel and housing relationships for the World Board and project workgroups. A growing part of our work is providing services to regional and area convention and event committees around the world on everything from contracts to committee structure and legal issues.

WCNA

Planning a world convention takes seven years. At any one time, we are simultaneously in some stage of planning and/or implementing four to five world conventions and usually one World Service Conference. WCNA-31, held in Honolulu, Hawaii, USA in September 2005, was a huge success financially and in attendance. With over 8,600 members registered and about 9,000 in attendance, the convention exceeded our projections by about 2,000 people. With the exception of a few members who inappropriately pushed several convention center personnel, the convention went very smoothly from an operational perspective. It is unfortunate, however, that the acts of a few stand to leave permanent negative impressions of our fellowship. The additional challenge we faced in Honolulu was 2,000 attendees who did not stay in official convention hotels and did not preregister for the convention, which caused significant operational issues for us on-site, since we had no way of knowing they were coming to the convention. The board plans to discuss this issue in preparation for the upcoming convention in San Antonio.

We encountered several issues when we considered the WCNA-34 bids from Denver, Colorado, USA; Los Angeles, California, USA; Vancouver, British Columbia, Canada; and San Diego, California, USA. The primary challenge was finding a venue that can handle 25,000 people for a main meeting. The second challenge was finding enough nearby hotels with sufficient numbers of guest rooms and adequate meeting spaces. These issues effectively eliminated Denver, Vancouver, and Los Angeles. San Diego, however, could easily meet our needs, and the city made us an offer that the WB could not refuse—so San Diego it is, again.

WSC

As the programmatic goals of each WSC become more complex, we continue to seek new and innovative ways to execute the logistics of the conference. Much of this work involves constantly maximizing and evaluating our use of technology. Additionally, as the workload for delegates becomes more complex, we continually look for ways to create an environment that nurtures discussion, consensus building, and a plan-driven focus for conference sessions. We were pleased that several new elements tried at WSC 2004 toward this end were successful and that the feedback from conference participants was overwhelmingly positive. As we move toward WSC 2006, we hope to continue and improve upon this success.

Projects Update

The following is a summary of the projects we worked on for the fiscal year 2004-05. These projects included the worldwide workshops, with World Board members and staff from NAWS supporting the participation of local members from around the world to discuss and identify challenges for the fellowship today. We also began work on the Basic Text project, the *Public Relations Handbook*, the Public Relations Strategy project, and Leadership Development. The work continues and is expected to meet target deadlines.

Worldwide Workshops

We've taken it "on the road" a slew of times this year. Two full-blown worldwide workshops, and no fewer than ten "mini worldwide workshops," had us traversing the globe for much of the year.

The worldwide workshop in Southern California in April 2005 drew about 200 participants, while the workshop in Tennessee, USA drew upwards of 300 people. Many regional delegates (RDs), alternate delegates (RDAs), and World Board members attended, adding to the strong regional turnouts we expected.

Worldwide Workshops continue to evolve and change. We have attempted to go to the next level in the wrap-up or conclusion sessions. We now try to help flush out and discuss solutions to the various challenges that are identified, and then encourage members to act locally, implementing the ideas identified during the workshop.

Some of the other events we attended were the South East Zonal Forum, the Mid-Atlantic Learning Convenference, the Asia-Pacific Forum and the Philippines Regional Convention, the Florida Service Symposium, the Plains States Zonal Forum, the European Delegates Meeting, the India Regional Service Meeting and Translations Workshop, the Ari-

zona Regional Learning Day, the Idaho Regional H&I Learning Day, and the Middle East workshop in Bahrain.



Staff support for each of these events is substantial. We have refined the process much over these past years, and our efficiency in the logistics involved has continued to make these valuable resources available to our fellowship. Plans for more worldwide workshops are in process.

Basic Text Project

The 2004 World Service Conference passed a motion to replace "some or all of the current personal stories" in the Basic Text, to add a new preface to the book, and to add a brief introduction to the personal-story section. The project plan for this revision spans two conference cycles, so the approval-form Sixth Edition Basic Text will be voted on at WSC 2008.

In February 2005, the World Board distributed a call to the fellowship explaining the project and what we are seeking. The solicitation was translated—in whole or in part—into nine languages other than English. A shorter announcement for use at local events was also drafted and posted on the web for easy downloading, and two workshops related to



the project were developed. World Board and NAWS staff conducted workshop sessions at several events, and we heard from members around the world who led workshops locally. Those events helped spread the word about the project, generated submissions, and were inspirational for the participants.

As we move from 2005 to 2006, the work-group will begin putting together and finalizing the draft text. The review and input period will begin in September 2006.

Public Relations Handbook

This workgroup was composed of members with experience in public information, hospitals and institutions, phonelines, and event planning. The ten workgroup members hailed from Brazil, Ireland, New Zealand, United Kingdom, and USA. The handbook is primarily focused on area-level services; however, it can be adapted to any service level. The first four foundational chapters were released for a ninety-day review and input period on 1 May 2005. These chapters are NA and Public Relations, Core Principles, Effective Services, and Interacting with Professionals. The second five chapters, scheduled to be released for review and input on 1 September 2005, are Media, Criminal Justice, Treatment, Healthcare, and Phonelines. The remaining chapters (Internet Technology, Government, Event Planning, and Fellowship Development) are scheduled to be released for a ninety-day review and input period on 15 December 2005.

This is the first time the board has put a project through the "Service Resource Material Process." We are beginning to see what works and what doesn't. The addendum material (like the Area Planning Tool) is a resource



that doesn't seem to fit neatly under the current policy. The intent seems sound, but locking ourselves into defined parameters may not serve us in the long run. Just for today, the *PR Handbook* is moving toward becoming the tool it was intended to be.

Public Relations Strategy Project


WSC 2004 also approved a plan for the development of a Public Relations Strategy project. This was the first time this board had embarked upon two related, but distinct, projects at the same time, and it was a growth opportunity. The PR Strategy and PR Handbook staff project coordinators attended and participated in meetings of both workgroups and shared information between the groups; and the two groups also had joint meetings. This helped to ensure that both projects progressed in tandem. Conducting two simultaneous public relations projects was not the ideal, but the communication and collaboration between the workgroups and the board worked well with these projects.

The PR Strategy Workgroup, armed with the PR Roundtable results and historical public relations reports and archives, was formed to develop a public relations strategy. The workgroup studied our public relations efforts on a broad, visionary level. It also considered detailed fellowship and NAWS PR activities. Needed PR strategies, resources, and tools were identified, and the PR Strategy Workgroup completed its work in June 2005. The final report and recommendations submitted to the World Board included many strategies that align with the NAWS Strategic Plan.

Leadership Development

During the course of this fiscal year, members of the World Board, Human Resource Panel, and NAWS staff met in facilitated discussion sessions to consider leadership cultivation and development. Strengths, weaknesses, and opportunities for involvement at all levels of the NA service structure were considered. Leadership development steps and possible strategies were drafted, beginning with a focus on service at the group level. We believe the group and area levels, together, are a cornerstone of leadership development.

Opportunities for cultivation, identification, and development of potential trusted servants/leaders at the world service level were also explored. In our assessment of the HRP/WB plan for a leadership development strategy, we identified where we meet and don't meet expectations. Action steps to help us evolve still need to be identified.

NA World Services Fellowship Development

NA World Services and our dedicated team of special workers, whose job is to maintain and improve our fellowship services, has completed another successful fiscal year. Services include local information exchanges, such as meetings, resources, and literature publications. Translations, fellowship publications, and Intellectual Property Trust are important features of our Fellowship Services. Online literature sales were updated this year with the new "online shopping cart," while our website and general information technology are growing and improving every day. Other important services include PR and marketing.

Fellowship Services

In fiscal year 2004-2005, the Fellowship Services Team fulfilled its mission by completing these and many other essential services:

- ◆ Compiled and sent out more than 1,000 new group starter kits
- Responded to more than 3,500 H&I requests
- ♦ Answered more than 10,500 telephone inquiries
- ♦ Responded to more than 6,600 emails and letters
- ♠ Responded to almost 900 miscellaneous requests, which included everything from Hindi keytags to an H&I Handbook needed in Estonia.

This team also maintains the database and enters information on new groups, trusted servants, and service committees into the database. NAWS continues to invite areas and regions to identify a web contact who can keep local meeting information current so that the NAWS meetings search page provides accurate information. As of summer 2005, there were 145 active web contacts. Areas and regions are encouraged to send to Fellowship Services any locally developed resources (training and orientation materials, minutes, guidelines, etc.) so that they may be made available to other service committees in need.

Translations

If you recall the popular translations map from a couple of years ago, "NA Speaks 47 Languages," you can get out your eraser and pencil, erase the 47, and insert a neat 55. As of 30 June 2005, NA speaks fifty-five languages, and we are involved with approximately 120 active translations projects. Two of our noteworthy projects for this year included a worldwide workshop for the Middle East NA communities in Bahrain and a translations workshop in Delhi, India.

In Bahrain, representatives from seven different Middle Eastern NA communities were brought together: Egypt, Iran, Bahrain, Kuwait, Oman, Lebanon, and Saudi Arabia. We made progress with Arabic translations protocol and a variety of fellowship development issues. World Board member Ron Hofius, Translations Manager Uschi Mueller, and Assistant Executive Director Becky Meyer represented NAWS at the Bahrain workshop.

In India, Executive Director Anthony Edmondson was accompanied by Mueller and Jeff Gershoff, a Fellowship Services Team member. This workshop was conducted in conjunction with the Society of the Indian Region Service Committee of Narcotics Anonymous, the largest NA region in India, and its semi annual three-day RSC meeting. Designated individuals representing a broad range of the languages spoken in South Asia participated. A greater number of languages are spoken in India than in any other nation on earth.

The Zulu translation of IP #1 is nearing completion. Work has been started on translations of IP #1 into other languages spoken in South Africa, such as Sesotho, Xhosa, Tswana, and Afrikaans.

Translations Activity Summary

As of June 2005

Fellowship Intellectual Property Trust

Narcotics Anonymous World Services maintains the trademark and service mark registrations of our name and logos in countries around the world. We are registered in thirty-five countries and are in the process of registering in additional countries, including countries in South America. We continue to file new registrations of our marks as needed, and we have filed all necessary copyright reg-


istrations for new publications. NA members and NA groups and service committees at every level of the service structure should continue to follow the rules of use for literature and logos as described in the NA Intellectual Property Bulletins:

- #1—Internal Use of NA Intellectual Property
- #2—Individual NA Member Use of Narcotics Anonymous Trademarks
- #4—Reprinting NA Fellowship-Approved Literature

According to a decision by the World Board, we uploaded seven informational pamphlets and group reading cards in each of the twenty-five languages by the end of this fiscal year. Limiting the number of informational pamphlets uploaded to our website made it possible to test whether we would encounter infringement problems and/or significant new legal expenses or issues because of this effort. Since we did not encounter these problems, we continued to add literature to the site. In early 2005, the board made the decision to upload all the informational pamphlets, booklets, and group readings. In June 2005, we began by uploading all information pamphlets, booklets, and group readings in English. This process is still ongoing in every one of the more than twenty-five languages in which we publish NA literature.

As we utilize the Internet in this way, we must remain vigilant in protecting our fellowship's property. Protection of our literature is the responsibility of the World Board, NAWS, and NA members worldwide. In fact, our diligence is even more important as we make our literature available in new ways. Posting our copyrighted literature on the Internet in any form increases the danger of unauthorized alterations being made to those electronic copies. An unauthorized copy made by downloading from a website is subject to a charge of copyright infringement, just as it would be if copyrighted print material was photocopied or reprinted without permission.

Protecting our copyrights and trademarks still requires legal actions that are neither simple nor inexpensive. It is our hope that we will not encounter such a situation. We have been entrusted by the fellowship, through the FIPT, with the responsibility to protect our literature and its trademarks. Failure to do so can result



in our losing the legal right to protect our copyrighted literature and trademarks against use by others. We ask that all of our members help to protect what is ours, so that our literature continues to bring recovery to hundreds of thousands of suffering addicts around the world. We cannot do this alone.

More information about the FIPT, how individual members can protect our literature, and the "do's and don'ts" regarding use of literature on the Internet is available on our website at www.na.org/legal/bulletins-fipt.htm or from NA World Services in Chatsworth.

Information Technology

Information Technology Services continued its ongoing investment in the technological infrastructure of NA World Services during the past year, utilizing available technology to provide the best possible support and services to our staff, members, and customers.

Our website is a key factor in our ongoing efforts to improve communications. We are experiencing continually increasing website traffic and activity. We have seen an increase in electronic subscriptions for publications,



improved registration processes for WCNA, and improved access to the review and input process for our membership, as evidenced by the *Public Relations Handbook* project. We are also exploring ways to make meeting information more accessible, current, and user-friendly, recognizing the reality that the accuracy of our meeting information depends on correct and updated user input from members of the fellowship. Some of the website statistics are included below:

- NA recovery literature online— 75,561 visits



We continue to work on reorganizing the website, which won't be done quickly. The most notable change to the website has been the posting of NA literature. As we reported last year, we uploaded a limited number of materials to see if we would encounter infringement problems and/or significant new legal expenses or issues because of this effort. Since we have not encountered these problems, we have continued to add literature to the site in twenty-five languages. Beginning in June 2005, we began uploading all information pamphlets, booklets, and group readings in English and Spanish. Once the Online Literature Sales option was available in May 2004, use of this function soared to 3,500 customers utilizing the service. The added Online Donation Portal, however, continues to be underutilized.

By posting NA literature on our website, areas and regions have the ability to provide a direct link to these documents from their websites, creating a seamless link, one where the user is not aware that they have even left the area or region's site. This resolves the problem we have had with portions and adaptations of our literature being posted on websites.

As we utilize the Internet in this way, we must remain vigilant in protecting our fellowship's property. Protection of our literature is the responsibility of the World Board, NAWS, and NA members worldwide.

Online Literature Sales and Donation Portal

In the 2002-2003 Annual Report we announced our expectation to add literature sales and a donation portal to the website within the next year. We achieved that goal in May 2004. Since then, it has been difficult to




imagine how we ever provided literature distribution service to such a diverse and widespread fellowship without this resource.

In July 2004, only a month and a half after introducing Online Literature Sales, we had three regional service offices and a few areas and individual members using this "online shopping cart" service. During that month we received 204 online orders, which represented 16 percent of all orders processed and 21 percent of the total literature income received for the month. Online literature sales increased each month, and by June 2005, eleven major regional service offices were placing their orders online along with many areas, groups, rehabilitation facilities, social services, correctional facilities, and individual NA members. Online ordering has more than doubled, with a full 33 percent (443) of all June 2005 orders being placed through the website, accounting for over 47 percent of that month's literature income.

During 2004-2005, 3,500 new customers used this service. Each month about eight orders are transferred electronically to our Canadian distribution center, and about five orders per month are transferred to our European branch office.

The total number of orders we receive monthly from all sources has increased by 21 percent over the prior year. During 2003-2004, over 38 percent of our orders were received by fax or telephone. During 2004-2005, fax and telephone ordering diminished to about 27 percent of the total orders received. A shopping cart order is about US \$6 less costly to process than a fax or telephone order.

The donation portal has not experienced as much activity as the shopping cart; however, several groups now regularly use this method for their monthly donations. Dur-



ing this fiscal year, ninety-six donations were received through the online portal, totaling \$6,562. Most donations were from members and groups. Donations were received from the USA, Germany, the United Kingdom, Brazil, Sweden, Canada, Uruguay, Israel, and Russia.

Public Relations and Marketing


Following the Public Relations Roundtable project completion in 2004, a workgroup was formed to develop a public relations strategy, armed with the PR Roundtable results and historical public relations reports and archives. In addition, one of the Fellowship Issue Discussion topics for the 2004-2006 conference cycle was "Our Public Image." The PR Strategy Workgroup completed its work in June 2005 and submitted its final report and recommendations to the World Board. Many strategic priorities for the 2006-2008 conference cycle align with recommendations forwarded by the PR Strategy Workgroup.

As work progressed on the *Public Relations Handbook* and *Public Relations Strategy*



projects this year, we also continued to participate in events where our presence could provide information to professionals who affect the lives of addicts seeking recovery. At each conference, we displayed and distributed NA literature. Many events are purely public-relations efforts that allow us to network with and become familiar with other organizations interested in helping recovering addicts, while others are opportunities to provide information about our literature and our fellowship.

Whenever possible, we enlist the assistance and participation of local NA members to help with our exhibit. This supports our efforts and gives local NA communities the opportunity to experience national or international events. It is an ideal opportunity for NAWS and NA



communities worldwide to work together in a spirit of unity and cooperation.

Fellowship Publications

Fiscal year 2004-2005 witnessed another year of growth for NAWS' major periodicals, The NA Way Magazine, Reaching Out, and Meeting by Mail. The growth of The NA Way was fueled by increased subscriptions in standard print format to well over 35,000 copies, and also by the implementation of electronic subscriptions. More than 1,700 copies of the magazine are now delivered electronically, with the number increasing daily. The NA Way Magazine is published in five languages: English, French, German, Portuguese, and Spanish. Another change for the magazine this year was the departure of Editor Nancy Schenk, who was replaced by De Jenkins.

One of our oldest publications, *Reaching Out*, continues to support incarcerated members as well as those H&I-minded members in the community. Our current printing for each issue of *Reaching Out* is approximately 9,000 copies. A single subscription to *Reaching Out* often includes multiple copies of each issue to facilitate local distribution by H&I subcommittees.

Meeting by Mail is delivered to approximately 1,000 different addresses every other month. Meeting by Mail allows addicts who cannot attend regular NA recovery meetings because of geographical isolation or physical infirmity to share their experience, strength, and hope in a newsletter and to correspond with each other independently, as they wish.

The participants in Meeting by Mail (MBM) are self-designated as either loner or nonloner. Many nonloners live in populated areas, and many do attend regular NA recovery meetings as well as participate in MBM. Some have difficulty sharing at a regular NA meeting; they feel less inhibited when sharing in writ-



ten form via MBM. The different sections of the magazine—New Loners, New Nonloners, Willing to Share, and General—let the editor indicate someone's "loner" status by placing their first letter in either New Loners or New Nonloners. Subsequent letters are placed in either Willing to Share or General, with different criteria determining the placement. When someone reading the magazine is taken with a particular "share," they can write the individual a personal response if they wish, as the mailing address of the participant is listed at the end of their letter.

Conference Publications

NAWS News

NAWS News provides an overview of world services activity, with an emphasis on World Board projects. It is published following World Board meetings and the World Service Conference in English, French, German, Portuguese, and Spanish. NAWS News is distributed to conference participants and registered area and regional service committees. Individuals can also request copies of this periodical after each mailing, and it is available on our website.

Conference Report

The Conference Report, a comprehensive and detailed report of world services activity, is published when the reporting needs of world services require it. This report contains information regarding the status of major world services projects, suggestions for new work, and challenges that have been encountered. It includes reports from the World Board, Human Resource Panel, and any region or zonal forum that wishes to submit material. The frequency of publication may change from year to year, and conference participants are provided with the schedule for each year in advance. The Conference Report can also be accessed on our website.

Conference Agenda Report

The CAR is published and distributed in English a minimum of 150 days before the beginning of each World Service Conference, with translated versions in French, German, Portuguese, Spanish, and Swedish released a minimum of 120 days prior to the WSC. This publication contains information about relevant WSC business, issue discussions, proposals, and activities that require guidance from the conscience of the entire NA Fellowship.

Regional motions to be included in the CAR for consideration by the WSC must be submitted 240 days prior to the WSC and must be accompanied by a written statement of intent. Regions can also submit a narrative of up to 150 words describing the rationale and meaning of the motion. The WB includes a recommendation regarding each regional motion to provide as much information as possible for the fellowship to engage in informed discussions of each proposal.

The CAR is distributed to conference participants and regions. Additional printed copies are available for purchase at cost from NAWS. The CAR is also accessible on our website at no cost.

NAWS Annual Report

The NAWS Annual Report provides a summary of world services activity for the prior fiscal year (1 July through 30 June). Once completed, it is distributed to conference participants and regions. Additional copies are available for purchase at cost from NAWS. The Annual Report can also be viewed or downloaded from our website at no cost.

Making Sense of Financial Reports

We hope this information helps those who are less experienced with accounting-type information find their way through the financial data provided below, and offers some points of reference to those with more experience. In our financial reports, the document that many commercial organisms call "Balance Sheet" is entitled "Statement of Financial Position" (SOFT), and the document that is commonly referred to as "Income Statement" is called "Statement of Activities" (SOA).

Our SOA is presented in two main sections: income and expense. To comply with an accounting standard required for non-profits, the expense portion is divided into four basic "activities":

- ♦ Literature Production and Distribution
- ♦ World Service Conference Support
- ♦ Fellowship Development
- ♠ Events

When reviewing the SOA, you will notice the line items "accounting", "personnel", "overhead", and "technology" included in each of the four activity sections of expenses. These line items are for expenses (such as building rent and utilities) that are not directly attributable to a specific area of activity. They are budgeted and allocated (distributed) according to a calculated fixed percentage. The calculated percentage is based on a combination of three factors: the number of personnel devoted to the activity, the approximate number of hours of labor, and the amount of physical office space needed for the activity. For this fiscal year (and for the two-year budget cycle), the calculated percentages for the four activity areas are:



The "Event Specific" section has no income listed for World Convention of Narcotics Anonymous XXXI, which took place in September 2005. Since we do not actually "earn" the income until the event happens (and this SOA is for our fiscal year ending 30 June 2005), we must record all convention money received prior to this date (September 2005) on our SOFP as a liability under the heading "deferred income." Much of the convention expense is likewise recorded under the heading "prepaid expense." These amounts are then counted as income or expense in the next fiscal year.


Where Does Our Money Come From?

Where Does Our Money Go?


Expense Breakdown July 2004 - June 2005

Recovery Books Distributed 2004-2005




Fourteen years ago the Basic Text was the only recovery book in our inventory. In calendar year 1991 we distributed 313,284 copies of the Basic Text (100 percent of recovery book units sold). That was a phenomenal increase from the 36,741 sold in 1983, when regular distribution of the book began. The Basic Text remains our best-seller, accounting for 48.7 percent of recovery books distributed this fiscal year (318,250 copies).

During the past fourteen years, *Just for Today* became available for sale in 1992, *It Works: How and Why* in 1993, *The NA Step Working Guides* in 1998, and *Sponsorship* in 2004. So, while Basic Text distribution has declined since 1991 (averaging around 275,000 copies per year in the past decade), the addition of these four books continues to push total recovery book distribution upward, with over 600,000 books sold per year. In FY 2005 we distributed 654,824 recovery book units, an increase of 85,562 (15 percent) over FY 2004. And from 1983 through the end of this fiscal year, 5,467,196 Basic Texts were distributed, representing 68.1 percent of lifetime unit sales of 8,032,710 recovery books.

The other four recovery books (excluding Miracles Happen) accounted for 51.2 percent of unit sales during this fiscal year. Just for Today: Daily Meditations for Recovering Addicts was our second best-selling book with 107,330 copies sold (16.4 percent of units distributed). The NA Step Working Guides surpassed sales of It Works: How and Why for the first time since it was published in 1998 (96,484 copies and 91,306 copies, respectively). We also distributed 1,113 copies of Miracles Happen: The Birth of Narcotics Anonymous in Words and Pictures.


The most exciting story this year was the publication of our newest book, *Sponsorship*. Following its release in November 2004, *Sponsorship* sold an amazing 40,341 copies, representing 6.2 percent of book distribution. This high volume accounted for the unprecedented 15 percent increase in total book distribution during this fiscal year.

Recovery Books Distributed 1983-2005




Unit Distribution Trends

Recovery Booklets Distributed 2004-2005




The peak year for booklet sales was 1991, when we distributed 735,914. For the first time since then, booklet distribution has exceeded this record with sales of 738,771 in FY 2005. The White Booklet remains the best-seller, accounting for 60.1 percent of units distributed. It is still our best-selling booklet of all time, with 7,191,539 copies distributed from 1983 through 30 June 2005. (Unit sales figures are not generally available prior to 1983.) The booklets classified as recovery literature are: the White Booklet, An Introductory Guide to Narcotics Anonymous, Working Step Four in NA, The Group Booklet, Behind the Walls, Twelve Concepts for NA Service, In Times of Illness, and NA: A Resource in Your Community.

Information Pamphlets Distributed 2004-2005




In this fiscal year, when IPs were made available for online viewing and downloading for the first time, we actually experienced an increase in IP distribution from 4,455,024 in 2004 to 4,958,716 in 2005—an extraordinary increase of more than 500,000 units. This increase is due, in part, to sales of the recently revised IP #11, Sponsorship.




Medallions Distributed 2004-2005

Years 1 - 22




Medallions Distributed 2004-2005


Years 23 - Eternity

Non-cash investing and financing activities: During the year ended June 30, 2005, NAWS entered into lease obligations for the purchase of equipment in the amount of \$655,098.

Notes to Consolidated Financial Statements

Years Ended 30 June 2005 and 2004

Note I - Organization and Nature of Activities

Narcotics Anonymous World Services, Inc. (NAWS) was incorporated on January 25, 1977 and is headquartered in Chatsworth, California. In addition, NAWS operates a literature distribution facility in Toronto, Canada and an office in Brussels, Belgium. NAWS is a not-for-profit organization which provides communications and information for the Fellowship of Narcotics Anonymous (NA). NAWS achieves its purpose by maintaining correspondence with NA groups and service committees, by printing and distributing World Services Conference (WSC) approved literature, and by maintaining the archives and files of NA.

In 1993, NA established the Fellowship Intellectual Property Trust (the Trust). The Trust was established for the purpose of holding and administering all recovery material and other intellectual properties of NA. The Trust is included in the consolidated financial statements of NAWS as a result of common control.

NAWS is exempt under Section 501(c)(3) of the Internal Revenue Code and comparable California Revenue and Taxation Code. The Trust is also exempt under the applicable Internal Revenue Code and comparable California Revenue and Taxation Code. In addition, the Internal Revenue Service has determined that the organization is not a private foundation within the meaning of Section 509(a) of the Internal Revenue Code. Therefore, no provision for Federal and state income taxes was made for either NAWS or the Trust.

Note 2 – Summary of Significant Accounting Policies

A. Consolidation Policy and Basis of Accounting

The accompanying consolidated financial statements include the accounts of NAWS and the Trust. Significant intercompany balances and transactions are eliminated in consolidation. The consolidated financial statements are prepared on the accrual basis of accounting.

B. Financial Statement Presentation

NAWS has adopted Statement of Financial Accounting Standards (SFAS) No. 117, Financial Statements of Not-for-Profit Organizations. Under SFAS No. 117, NAWS is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets and permanently restricted net assets. As of June 30, 2005 and 2004, NAWS held no temporarily or permanently restricted net assets.

C. Cash and Cash Equivalents

NAWS considers all funds held in checking and savings accounts to be cash and cash equivalents.

D. Investments

NAWS investments are carried at fair value which generally represents quoted market price as of the last business day of the year. The certificates of deposit are valued at cost, which approximates fair value.

E. Publication Inventory

Publications and other items for resale are included in inventories and are carried at the lower of cost or market, with cost determined by the first-in, first-out method.

F. Property and Equipment

Leasehold improvements and furniture and equipment are stated at cost. Major additions are capitalized while replacements, maintenance and repairs, which do not improve or extend the useful life of the asset, are expensed. Depreciation is computed using the straight-line method over the estimated useful lives of the related assets, which range as follows:

5 years

5-10 years

Leasehold improvements
Furniture and equipment

Depreciation expense for the years ended June 30, 2005 and 2004 amounted to \$212,902 and \$177,072, respectively.

G. Trademarks and Copyrights

The cost of acquiring and defending copyrights and trademarks is capitalized and is being amortized over the approximate economic life of the copyright or trademark, which is estimated to be ten years. Amortization expense for the years ended June 30, 2005 and 2004 amounted to \$113,936 and \$107,467, respectively.

H. Accounts Receivable

Accounts receivable are reported net of an allowance for doubtful accounts. The allowance is based on management's estimate of the amount of receivables that will actually be collected. Management estimates uncollectible accounts based on the age of the receivable and other factors.

I. Allowance for Doubtful Accounts

Allowance for doubtful accounts is estimated by management based on the experience of accounts receivable collectibility.

J. Translation of Foreign Financial Statements

Financial operations in Canada and Europe are translated throughout the year to United States dollars. Gains or losses resulting from translating foreign currency financial statements are recorded in the consolidated statements of activities.

K. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Note 3 – Retirement Plan

NAWS maintains a qualified defined contribution retirement plan which covers all employees. Under the terms of the plan, employees may elect to contribute pre-tax earnings up to the maximum allowable amount. NAWS matches up to 5% of the deferred earnings based on the employee's number of years of service. The matching contribution to the plan for the years ended June 30, 2005 and 2004 was \$46,541 and \$44,251, respectively.

Note 4 - Operating and Capital Leases

NAWS has entered into capital lease agreements for the use of telephone and office equipment. The total value of the equipment under capital leases is \$734,024. NAWS also leases equipment and facilities under various operating leases. Minimum future lease payments on noncancelable lease commitments, including interest on capital leases, subsequent to June 30, 2005 are as follows:
