GROUPS / MEETINGS

There are approximately fifty - sixty groups in the region currently. From those groups, approximately one hundred meetings per week are held. Activities is a busy committee, bringing to our Region regular scheduled events like the Regional Talent Show in April, Festival of Recovery in June and The Regional Bash in Tucson. This year I saw increasing efforts to cooperate between committees and encouraging efforts not to over extend ourselves.

Our Literature Committee (a strong membership of One) has persevere this year. The establishment of literature distribution to outlying area service committees, groups and isolated meetings began. Our aim is to save money for the areas and our N.A. fellowship as a whole.

The Fifth Annual Arizona Regional Convention of Narcotics Anonymous as usual is laboring hard to make this years convention a huge success. This year ARCNA V will be held in Tucson.

This year the R.S.C. put on two Learning Days. One focused on N.A. Services, R.S.C. and MONEY. The other Learning Day focused on P.I. and H&I. Some of the areas put on Learning Day Events also. Open dialogue and communication has been good.

Fellowship Report To The WSC On The Australian Region

The number of Australian Regional meetings is 227. This small increase indicates we are going through a period of consolidation after a few years of rapid growth. Travel Cost equalization for RSC participation is firmly in place but has placed a strain on smaller areas of the region who sometimes feel that their funds have more important priorities. There are 14 in our region and meetings are concentrated in larger quantities in and around Sydney (89 meetings) than in other areas.

For over twelve months now there have been difficulties administering and servicing the four Sydney areas. Two open forums on the issue and much discussion has resulted in a committee being elected to propose a satisfactory service structure and guidelines that will meet the needs of this large metropolitan area.

Growth in other areas has given rise to a movement for more truly regional participation other than ASR'S attending RSC's and ways to spread this throughout the region are being explored. We are a geographically large region and travel time and costs have made the theory of a truly Regional RSC difficult to put into practice.

Our Fellowship Service Office (FSO) continues to function effectively and viably. Following a visit by WSO representatives last August an agreement was reached formalising our relationship with WSO re printing royalties on literature.

Our relationship with the New Zealand RSC and the FSO has still not been resolved terms of Board participation and literature sales.

Our Outreach committee continues to maintain contact with outlying and isolated meetings. They seem to come and go on a regular basis and have been hard to bring into the service structure.

Our P.I. efforts in the Australian Region have resulted in Radio and T.V. PSA's being played in many areas. A Billboard has been completed and placed in Sydney. Many and varied presentations and responses to public enquiry continue.

There are twenty seven meetings who participate in the N.A. attendance form signing scheme, and a new T.V. P.S.A. from the WSC is being adjusted to meet our Australian requirements to supplement the one we have had for some time.



All area and regional sub-committees waiver with commitment, enthusiasm and gratitude. Their strength and productivity varies in size from year to year, but nearly every area has their full compliment of sub-committees.

The whole Australian Region is looking forward to hosting this years World Convention in 1991. Only a few Australians have been fortunate enough to experience the thrill of a World Convention. Our host committee is working hard with the W.C.C. to make this event a great success. We are hoping to see as many world-wide members as possible and can assure them they will be warmly welcomed.

There will be no Australian Regional Convention this year due to lack of bids from areas and attempts by the RSC Administrative Committee to get a Convention Committee together have not succeeded.

Generally the Australian Region is mature and stable, and offering a sound base for the introduction and development of N.A. into other nearby countries.

Greetings fellow RSR delegates from beautiful British Columbia, home of the most recovered addicts in the Canadian mosaic. We have been dysfunctioning as an established region since March, 1985. This is our sixth report to WSC. Unfortunately for our region we too have discovered that quanity of clean time is not always proportional to quality of recovery.

Currently our arsenal of recovering addicts is mobilized over 126 meetings/week extended over some ten geographical district areas with only minor changes in troop deployment from the regions year. Our current donation to WSC is \$750 which I believe is substantially less than last year as half our donations are going toward CANA, our own Canadian Assembly. This we suspect may be a trend of the future as our own international groups become more self supporting.

Newswise, we have been supporting the latest trend in N.A. by hosting two mutli-area workshops and one multi-regional workshop to facilitate improved service to the fellowship and get out a more effective message of recovery in both H&I and P.I. announcements.

Greetings to all, from the WSC to the members of Narcotics Anonymous!

We have undergone another year of intense growth for the 9th consecutive year. The past one has proved itself to be full of surprises as we have subdivided and aided in the process of forming a new region, the Free State. At the WSC we will be requesting that you seat the Free State Region. God knows we love our brothers and sisters and growth is often in spite of ourselves and our addiction!

Our region currently stretches from most of Delaware, Eastern Maryland and the Atlantic Ocean to our east, Southern Maryland and Northern Virginia to our south, Frederick, Maryland to our west, and Laurel, Maryland to our north. We currently are comprised of twelve (12) areas which are acknowledged as follows: Central Maryland, DELMARVA, District of Columbia, East of the River, Frederick, M.A.R.S., Montgomery, NORVANA, Ocean Gateway, Rock Creek, South Potomac and Tri County of Southern Maryland. With these areas we have approximately 409 meetings and 99 H&I meetings. The rooms are representative to the membership of our region and are made up of many newcomers and oldtimers alike. In most cases, there within is amplified an atmosphere conductive to the recovery process and dialogue about recovery form the disease of addiction.

With our most recent struggle, searching for a new identity, we have experienced grief from the loss of many friends in service. In this light of things, we have continued to function most effectively by continued delivery of the message of recovery to the still suffering addicts. Our subcommittees remain eager and employed with the working of our areas in the day to day operations of things. These subcommittees are affirmed as follows: Activities, Administrative, Convention, Hospital & Institution, Literature, Policy and Public Information. They admirably serve the whole, where the needs are so great, by selflessly giving. Thanks to all!

Our region is current host of two conventions now up and coming. The first will be our regional convention CPRC V which will be hosted by the Bay Area of the Free State Region. They were service oriented enough to be the only bid at our regional and were consequently awarded the honor to serve. This took place even as our region was in the middle of subdivision. See miracles do happen when we let them. Our convention will be held on 4/5-7/91 in Ocean City, Maryland at the Convention Center; moreover, where there's plenty of room, good places to eat and/or exercise, and miles of beach to enjoy practically all to ourselves, with a boardwalk. Last year there were a few thousand addicts and this year, we expect to at least duplicate that experience thanks to the Bay Area. The second convention being hosted by part of our region is the ECCNA 12 (East Coast Convention of NA). District of Columbia, Rock Creek and East of the River have gotten together to sponsor this event. It will be held at the University of Maryland, College Park Campus on the weekend of 6/21-23/91. In order to assure financial accountability, the convention committee has installed numerous checks and balances. Some of these are as follows: the hiring of an outside CPA for auditing purposes, incorporation and several other internal checks. Their plans are to initiate a clean up of this convention's blemished past. Currently the bid process is under close examination and the lack of accountability to any point within our service structure as well. There is also a new medium of communication in which this is undergoing close scrutiny and might possibly be dealt with. This convention will possibly be heralded as one of NAs' largest due to the inexpensiveness, the massive housing capacity and the locale in the center of the east coast between Florida and Maine. We hope you will be able to come and celebrate recovery with us at both of these awesome events.

The C & P has continued to be involved in the Workshop of Regions as the sponsor/host. The attendance has fallen off through the winter months, but we expect as spring again brings forth the blooming flora, it will too bring addicts from afar. We are currently considering changing the name to Eastern Multi-Regional Assembly and instituting a membership. More Will Be Revealed!

Connecticut Region Yearly Report

Greetings from the still growing fast and strong Connecticut Region of Narcotics Anonymous.

The past year has shown an increase of almost 50% of N.A. groups who are registered with our region. We now have approximately 220 meetings compared to 150 last year. Two of the new meetings are H.I.V. meetings. They are in two different areas, open to all addicts and appear to be running smoothly.

We also have about 70 H&I meetings thru-out our small and accessible state, this is an increase of 20%. We are especially proud of the efforts put forth by all the addicts who serve our H&I subcommittee. The Connecticut Region has a long history of carrying the message into our hospitals and institutions and this year we continued this combined effort.

Not to take anything away from our other subcommittees, our Regional Literature Committee held five workshops on "Restoring Relationships." Their input from our experience was sent in to help out for this important recovery tool.

P.I./Phoneline introduced our region to an answering service/voice mail system with an "800" number and it has helped to solve a lot of problems in this area.

We also formed a convention corporation with a working board of directors. Our Higher Power has blessed us with the addicts and resources to initiate the effort to form this much needed committee.

We started the New Year "91" off, as usual with our 6th regional convention. Twenty-five hundred addicts attended. Freedom, love and spiritual growth were abundant thru-out the weekend.

We added another area this year, we now have eight. We also are having our first area convention in April and another area just decided to have theirs in the near future. Both areas are putting the stress on carrying the message of Narcotics Anonymous and to celebrate our recovery and unity.

Lastly, following fund flow we have contributed \$2661.43 to the World Service Conference. We are gathering experience to improve our fund flow system and to be resourceful in our expenditures.

Communication thru-out our region is good and thru the help of a loving God in our recovery we hope to be a small part of carrying the message of Narcotics Anonymous to the suffering addict.

Greetings from the Greater Illinois Region of Narcotics Anonymous.

In our fifth year as a Region, our Regional Service Conference meets centrally in Peoria Illinois on the second weekend of the even months. Note our letter-head which reflects our new mailing address.

As noted last year, our Region has continued to be supported by four areas. In the last few months however, four new areas have formed and we hope to serve them soon. There has been an approximate 20% growth in the number of meetings within the Region. Groups seem to be more aware of the functions of the different service arms of NA, but frankly there is still marginal interest and little support for them. The use of newsletters as a form of communication in our Areas has increased, resulting in growing awareness and hopefully future involvement.

There is a Regional Formation Committee active in North Western Illinois. We have only sketchy details of their progress, as presently we have not been involved in their decision making process.

This year our RSC held its first inventory. One of the results has been increased interaction with our neighboring Regions, particularly ChicagoLand and Indiana. This has lead to joint CAR Reviews with them. Hopefully in the future we will continue to avoid self inflicted isolation.

Our Region contributes three members to WSC Committees (PI, Lit, Isolated Groups). Our RSR and RSR-Alt have attended and contributed to all WSC Workshops this past year. We are also looking forward to involvement at the WSC in April. We continue to support the Mid-Coast Convention.

On a Regional level our committees are functioning as follows:

Public Information - Not presently active.

<u>Hospitals & Institutions</u> - This committee has recently reactivated with a core group and is beginning to function again. <u>Policy</u> - This committee is quite active developing Regional Policy.

<u>Literature</u> - Meets regularly with varying support. Has contributed input on various WSC Lit projects.

Activities - The Activities Committee has reduced the number of Regional functions from six to three due to lack of support. The three Regional functions are: 1) CAR Review in March, 2) Volleyball/Recreational tournament in July, and 3) A spiritual meditation day in November.

Adhoc on Guide to Service - This adhoc committee has reviewed the Twelve Concepts and sent their input to the WSC.

We struggle somewhat awaiting increased support; however we are stable and very grateful for the privilege to be of service to our Higher Power, our Region, and NA as a whole.

Greetings from the Greater New York Regional Service Conference. This past year has presented us with many challenges, which, to a great extent, we were able to overcome due to great teamwork within the region. Just to mention two:

Our Central Office was broken into and our Helpline equipment stolen. Through a concerted effort of the part of the members of our Helpline and our Answering Service, we were able to service the region by using a combination of member phones and the answering service system.

On the financial front, while our annual convention was a tremendous success from a financial and recovery view point, towards the end of the year the region found ourselves in a financial bind as donations were not matching expenditures. We have formed a financial committee whose job is to review all cash flows (donations to the region, revenues to the Convention Corp. and to the Office Corp.), consolidate these budgets and formulate a reasonable financial plan for the coming year. This plan will encompass the cost of all services rendered by the subcommittees of the entire region.

The region continues to grow and as of February 28, we had 1,046 meetings registered with our Helpline within our 14 areas. The chart below details the area's groups and meetings in the Greater New York Region.

HOSPITAL AND INSTITUTIONS: This subcommittee now carries 432 weekly meetings into the hospitals and institutions within our region. Their main event this past year was learning day which was held in a medium security prison. The consistency and perseverance of the members of this subcommittee led to an invitation "Behind the Walls" from the Washington Correctional Facility in Upstate New York. Thirty experienced H&I members were admitted for six hours to conduct a five-hour learning day. With access to approximately 360 inmates on a voluntary basis, 120 attended. The day consisted of an opening meeting, five workshops a closing meeting. The day was a rousing success and the first of its kind in our region. State level government officials were so impressed with this presentation that they are planning another event of this magnitude this coming Spring. Over the past year, H&I has encountered problems funding the literature requirements for these meetings. They continue to work on this problem.

<u>HELPLINE</u>: The Greater New York Regional Helpline has answered approximately 24,000 calls in 1990. There was a period of time when we had no phones. The committee pulled through and picked up calls from their homes. Some of the areas came to the committee for guidance and information to start their own Helplines. Currently, there are three (3) local area Helplines within our region, in addition to the main regional-wide Helpline.

<u>POLICY COMMITTEE</u>: This past year, the Policy Committee has worked towards updating and compiling the region's existing policy, drafted election and nomination forms for use in conjunction with regional elections and drafted a short form of Robert's Rules of Order/Parliamentary Procedures for use at GNYRSC meetings.

<u>PUBLIC INFORMATION COMMITTEE</u>: PSAs are being aired for the first time on a cable TV show, the "Recovery Show." For the first time, P.I. made a presentation to magistrates in Ulster County.

EVENTS AND ACTIVITY: Once again, this committee had an extremely successful year. Among its achievements was the arranging of a bus to carry people from this region to the Arlington, VA quarterly. They also organized our Gratitude Breakfast and the Pioneer Dinner Dance, both annual events within the region. We also held a boat ride which traversed around the island of Manhattan and was completely oversubscribed. As a supplement to our annual convention, this committee organized and held a "Fun and Recovery Weekend" in the Catskill Mountain Region.

GREATER NEW YORK CONVENTION CORP.: This past year, the Convention Corporation ran the Sixth Annual GNYR Convention -- "Freedom VI." The convention was a success when measured by recovery, attendance, and financially. We had approximately 2,000 weekend registrations and another 2,000 to 2,500 day registrations. The peak attendance approached 5,000. The corporation also coordinates the Regional Service Committee weekend meetings in conjunction with the E&A Committee. They have organized three of these in 1990.

GREATER NEW YORK REGIONAL SERVICE OFFICE: The Board of Directors this year continued its efforts to improve the accountability of the RSO, Inc. and to improve the dissemination of financial information to the fellowship while also increasing the availability and level of service to the fellowship in the spirit of our First Tradition, Unity. We have hired the accounting of Owen Flanagan to assist in our filing of 1023 Federal Government Not For Profit Status Application. We have compiled and submitted financial records for the years 1986-1990, and are presently assembling additional figures requested by them in final preparation for filing. All financial records are being entered into our computer system.

In February-March, we suffered a series of break-ins which necessitated the installation of an electronic security system for the RSO, Inc.

This year, we reached our projected literature sales figures of \$250,000.00. We did this while lowering our sales price to WSO list price in August. We continue to produce the GNYRSC Meeting List which now contains 1,020 meetings. We continue to sell it for \$.25. We are now able to generate camera ready art from our computer; we have three scheduled printings a year. Through creation of a Finance Subcommittee in May '90, the RSO BOD, Convention Corp. BOD and RSC Administration, we have compiled a comprehensive documentation of annual expenses and we are moving toward gaining a unified solution to the financial problems which the three bodies share in our provision of services to the fellowship and its service structure. In December, we have written our first Employee Handbook and dissolved our interlocking directorships between RSO and Convention Corporation. We also took part in the WSO RSO Conference in Chicago and await further information and input on the future of literature distribution within the fellowship.

METROPOLITAN SERVICES, AD HOC COMMITTEE: During the past year, the Queens Area, which is one of the five NYC County/Area's experienced a split. This split was met with much controversy as the "Mother Area" did not support the split. As a direct result, an ad hoc committee was formed to deal with issues such as area splits. The purpose of the committee was to create options for the division of metropolitan county areas when they choose to do so. While a number of options were discussed, the committee felt that districts (a level of service between the groups and the area) was the option that would best serve our area's current needs, keeps borough/county-wide services in tact (i.e., H&I, P.I., etc.), yet does not effect N.A. in our region as a whole.

Welcome from the Greater Philadelphia Region!

It has been a year of growth and struggles for us. We have gained two new areas, the Scranton Metro Area and the Schuylkill Valley Area, which now give us a total of eleven areas within our region. With the growth from these areas, our region now stretches from Northeastern Pennsylvania to the Southeastern border and into Delaware.

Greater Philadelphia continues to have regional weekends which are hosted by the different areas. We are currently changing this model to have the weekends at one location for a period of one year, to gain more consistency. We will continue, however, to have subcommittee meetings on Saturday with a dinner, speaker and a dance, along with the regional meetings on Sunday.

We are experiencing some difficulties with support on the subcommittee level and as a result some committees may be dissolved and/or combined. The P.I. committee has increased its level of presentations this year but is having difficulty with the local press due to the fact that we do not give our full names and discuss specifics as far as they are concerned. We hosted a Multi-Regional Learning Day with the participation from a number of regions. H&I is doing well, has support and is continuing to interface with area committees. The Greater Philadelphia Regional Convention will be held on March 8, 9, & 10, 1991 at the Sheraton in Valley Forge, Pennsylvania.

The convention is experiencing difficulties with not enough pre-registrations. We also had four new area conventions and quickly realized that this was becoming a problem. Other subcommittee functions were being drained of both human and financial resources. We also came to realize that we could potentially have an area convention every month in the region.

RSO:

There has been more growth in the RSO board in terms of accountability and area support in the past few months. We have hired a "Special Worker" for twelve hours a week and have considered expanding the office functions to include the Cleansheet, our Regional Newsletter, a centralized Phoneline, and a satellite office in our northern areas.

Over the past year the region has addressed the issue of prejudism a number of times. Our convention has a topic meeting concerning this issue. Prejudism is an issue that we have not been able to resolve but hopefully more will be revealed.

"BABY BLUES"

In the past year, as most of you know by now, the GPR has been at the center of the controversy surrounding the printing and distributions of the Baby Blue Books. From the beginning, the GPR was not in favor of these actions. The regional policy began to remove from office any individual involved in this. Two of these persons were removed.

We continue to be concerned about the direction in which the fellowship is heading. We realize the need for change and growth. We hope that the "New World Order" does not force us into a situation where we must change our basic beliefs and love for Narcotics Anonymous in which we grew up.

We hope and pray that we can come to a common solution to our common problems.

Indiana Region Annual Report

The Indiana Region's 5th year was a period of transition. Although we have not increased the number of Areas or meetings, we have experienced growth in the membership. The Region has a total of 8 Areas with 208 meetings at the latest count. Our donations to the WSC from February 1990 through February 1991 total \$1,775.80.

The Indiana Region enjoyed the priviledge of hosting the 6th Mid-Coast Convention in Indianapolis in July 1990, and was able to send the WSC \$1,186.26 of its success. Fort Wayne is honored to be hosting MCC 7 in July 1991.

Policy Subcommittee

During the past year, the Policy subcommittee was given several major projects, some which are still in the review process. These include: possible stabilization of the regional meeting; open workshops on the proposed "Guide to Service"; updating the Regional Policy manual with the possible addition of a section on parliamentary procedure; and, establishing the process of a regional inventory. As of date, the review workshops on the proposed service guide and the updating of the IRSC Policy manual continue to be ongoing projects. The matter of a regional inventory will be completed at the February 1991 RSC, and the region has decided to continue the rotation of the IRSC. With the consistent attendance of active members, Policy has been registered with WSO and hopes to remain an active link in our service structure.

Funding and Functions Subcommittee

The IRSC F&F subcommittee had one fundraiser this year, the Unity Dance, in Lafayette, Indiana, on November 10, 1991. The function raised \$871.75 towards the delegate fund. We also have a new T-shirt design for our Region.

Public Information Subcommittee

For most of 1990 there was no P.I. chairperson and little if any activity occurred in Public Information on the regional level. In December the subcommittee began to form again and now has a new chairperson. Current efforts are on establishing communication between the region and area Public Information subcommittees. Discussion is evolving concerning the use of one areas' 800 number for a statewide phoneline.

Hospitals and Institutions Subcommittee

We have 32 H&I meetings in 6 Areas at this time. Our other two Areas are working to get active H&I subcommittees started. As with the other regional subcommittees, H&I has experienced a change in chairpersons and is struggling somewhat with the transition. In November 1991, we hope to host another multi-regional H&I Learning Day in South Bend, Indiana. Date and times to be revealed in the near future.

Literature Subcommittee

The IRSC Literature subcommittee has once again gone through a period of great change during this past conference year. We have elected a new chair, suffered the loss of our regional newsletter, and have transferred our regional meeting directory to a new and seperate subcommittee. Our only review project this year was the pamphlet, "Unity", the input on which was forwarded to the WSCLC. The coming year shows the promise of increased communication with three fledgling area literature committees, as well as continuing to work in cooperation with our WSCLC.

In closing we would like to say we are looking forward to a productive WSC in April and wish all the best in recovery.

During the break between the Fall and Winter RSC the rent for our P.O. box lapsed. Due to mis-communication, the box was closed out and rented before we became aware of the problem. The new mailing address for the Iowa Region is as follows:

REGION IN GENERAL:

The Region has struggled with many problems in the last year. There is often a deficient flow of information throughout the service structure. Many members expressed dismay when they have learned after the fact that a function was held. The fact that many of our groups are not represented at the ASC contributes to this issue.

There are several factors such as lack of commitment to service by trusted servants, members unconcerned or uninformed about the need to serve; these factors have created an information vacuum within the fellowship.

Due to this vacuum, many of our groups have no input or representation at any level of service. Many of these groups struggle with just getting someone to set up and chair the meeting.

At the Area level, groups have reported difficulty in filling service positions. Although a number of newcomers do stay clean, even after fulfilling suggested clean time requirements, there remains an apparent reluctance on the part of MOST to get involved in service. Many service committees consist of a group of servants who have been trading positions in order to keep the committee functioning. Subcommittee support at the ASC level is almost nonexistent in some cases.

The RSC is attended presently by 11 Areas as opposed to 15 in years past. Some of this is due to consolidation, some is due to lack of representatives. At a recent Regional Lit. workshop, only 4 members attended. This is indicative of the involvement in other Regional subcommittees. There is better participation on days when the RSC meets. There is some work getting done, but the members doing it are getting burnt out. We have recently revived our Regional newsletter.

REGIONAL SERVICE COMMITTEE:

The RSC has been centralized to make travel by ASR's more equal in distances as well as cost. By centralizing, we have made the trip to the RSC less taxing and more attractive to the fellowship as a whole.

Throughout the last year this committee has been struggling with policy. Since we have no clearly defined rules of order, this has been a great concern for us. After nearing completion on a package, motions indicative of the

lack of order have restarted the process which will now continue into 1991.

This process has been painful; an ASR walked out of the last RSC because they felt the level of personality presence inhibited the unity process. The unfortunate result of this process has been that the RSC has not been able to deal with other issues related to service for the Areas.

There has been some issues with finances. Since the RSC is mainly funded by the Regional Convention, there is concern about what is considered self-support. There has been a problem with lost receipts, and some differing conscience on whether being a trusted servant involves the required expenditure of personal funds; ie. officers travel expense, travel for Region-sponsored events such as workshops and the CAR review in each Area. However, the RSC did adopt a \$200 food budget for the purpose of supplying lunch to the RSC participants.

REGIONAL SUBCOMMITTEES:

Subcommittees have been maintaining a level of service consistent with last year, however, attendance levels have dropped, making this task much more time consuming for the dedicated servants. The subcommittees meet 8 times per year but we are considering dropping to 4 times a year to bring expenses more in line with involvement. The Lit. subcommittee has been active in reviewing fellowship literature and publishing the newsletter. The PI subcommittee published a Regional 12 step directory, and H&I has been somewhat idle. AREA SERVICE COMMITTEES:

Many ASCs have been dealing with misappropriation and irresponsible handling of fellowship funds. Most of the problem stems from the "hat" not making it to the bank, theft, and lack of responsible accounting for expenditures.

There has been an increase in the frequency and quality of ASC sponsored events such as dances, learning days, and workshops. Participation levels vary, but the ASCs report much success in these efforts to serve the fellowship. GROUPS:

There is a strong need for information to find its way to the groups. Recently a member stated his belief that the illegal basic text was the product of a group of WSO workers who diverted funds to publish it! Lack of willingness and commitment among the membership has created an environment that allows this sort of disinformation to be passed from one unrepresented group member to another. The problem of unwillingness to serve is severely crippling some groups in the 5th tradition effort. Recently a ten year old group closed its doors due to lack of support. We feel confident that this problem is not unique to our Region and will hopefully be a rare event. We have enjoyed an influx of newcomers.

The unwillingness to serve by the majority of members has left those serving doing more than their fair share, open to attacks of ego, and forced to make personal decisions rather than expressing the conscience of those they serve.

IRISH REGION

Greetings from the Irish Fellowship to W.S.C. & best wishes within the spiritual principles of our program for the 1991 Conference.

We would like to confirm that there is support & gratitude within the Irish fellowship for World Service efforts & we appreciate the opportunities available to

us to learn from the wider growth outside Ireland.

There has recently been a reshuffle in the Irish Region. We have only the Dublin area (at present) participating & we are working on becoming a unifying committee once again. On recognition of the need for clearer direction among members we have written up guidelines within which to function & we feel sure we will "get there".

At present we have 20 meetings in Dublin, 3 in Cork and 1 each in Kerry, Galway, Limerick, Waterford, Wexford & Belfast. We understand the groups outside Dublin are strong & offering recovery to addicts the N.A. way. We look

forward to their participation in the region.

H&I. There are N.A. meetings in 3 treatment centres & the main Detox clinic in the city. These groups are well supported. A new meeting has opened in the Needle exchange & we hope to see it continue to grow. Prison meetings are not running so far this year. One request from an inmate is being taken care of by the Committee. They ensure regular post of the N.A. Way magazine & he has personal communication with 2 members chosen by H&I.

P.I. There has been a new committee elected & they are busy with a lot of requests for talks & participation in non N.A. events. This fresh committee will continue to run already established events and hope to introduce some new projects

where ever they can.

The phone-line committee has become a separate entity to the P.I. com. as the demand on the helpline is great & thus needed the individual attention of the phone line com. They supply a 24 hour helpline.

Convention Committee

The 1990 convention has very successful. The convention committee wish to express their disappointment at not having notice of the event included in the N.A. Way magazine. They feel it was lack of cooperation from W.S.O. & wish to sort it out with them.

- Office. The office has had to close due to high rents & bad conditions i.e. dampness. At the moment literature is being distributed at the A.S.C.
- Fundraising Committee had 1 or 2 successful fundraising events, 1 or 2 not so successful & they have disbanded. It's looking like there is another committee to take their place.
- E.C.C. The European Convention Conference has always been well attended by the Irish. This year one Irish member was elected to the European Study Group. A fundraiser organized by him for E.S.G. raised 170 Irish pounds.

PLEASE NOTE:

The dates for our upcoming convention were incorrectly reported in the NA Way. It will be held on 5-7 April. Registration Forms available from the above address.

This is the eleventh year since the first meeting of addicts in Narcotics Anonymous in London.

London Region is composed of five ASCs: Brighton (9 meetings), Northeast (27 meetings), Northwest (25 meetings), Southeast (30 meetings) and Southwest (28 meetings). One hundred miles separate the furthest meetings. Our 119 meetings represent 10% annual growth.

The greatest growth sectors are in Brighton and among non-English meetings. The NA message is being carried in Italian, Spanish, Portuguese and French. Other non-English speaking members have contacted our regional office. There are increasing numbers of meetings with childcare facilities. Special interest groups include women's (4), men's (2), gay, and illness in recovery meetings.

SUBCOMMITTEE ACTIVITY

Lit - No activity this year.

- PI The Chair and Vice resigned, LRSCPI currently does not meet. There is an effort to have area PI committees present at the office subcommittee in field requests that come in via the phonelines. NA posters with our helpline are available to area literature secretaries. The north areas and south areas each have joint PI. Brighton has just formed their own committee. South areas PI hold a successful Learning Day for professionals last March and plan another this March. LRSCPI have developed a statement of purpose and suggested clean time requirements.
- H&I The annual inventory revealed that some secretaries are taking meetings with little support or accountability. With the help of the European Service Office (ESO) computer, LRSCH&I have created a form to assist recovering addicts getting clearance for service in Her Majesty's prisons. Eventually a database will be compiled. Guidelines for meetings in Drug Dependency Unity were developed by the south areas. Future goals are to develop guidelines for the subcommittee, for members subpoenaed to court hearings, for sponsorship of incarcerated addicts.

LONDON REGION SERVICE OFFICE - LRSO reported a 30% increase in number of calls received, with a smaller increase in the number of addicts calling the helpline. Volunteers are always needed to staff the daily 8 hour shifts; rarely are two addicts present to share each shift. Great progress has been made in referring 12th Step calls, creating a statement of purpose and guidelines. A future goal is to look at diverting calls instead of having them answered at the office. Postage, rent, insurance, photocopier and phone bills amounted to 7580 last year.

OFFICE AFFAIR AD HOC - The LRSC hosted a multi-regional Learning Day following the European Conference and Convention (ECCNA) in Lisbon. We scheduled presentations by LRSO volunteers, the UK Service Office (UKSO) special worker, members of the UKSOBOD, the ESO Special Worker and a WSO executive. We were particularly pleased to offer our strength, experience and hope to members from Paris. There were more than 50 participants from Australia, England, France and the US, including a Trustee, and members of WSC subcommittees.

Any members with service experience planning on being in London after attending ECCNA VIII in Rome are encouraged to let us know at the above address.

AD HOC ON NA SERVICE - Was able to review the 12 Concepts, although not the Guide. Input on the Concepts was forwarded to WSC. The goal of the committee is to continue work on the revised Concepts.

AD HOC ON VIABILITY OF LRSC - The final proposal called for RSC business to be restricted to quarterly Learning Days and hosting an annual convention. Area fund flow and representation at WSC would be done via the UKSA.

The LRSC suggested that the Ad Hoc not attend each ASC to present their conclusions, and attempted to add their findings to our regional inventory last January. The UKSA will not be represented at WSC this year. The LRSR was asked to have the issue of seating national assemblies placed on the agenda for the upcoming International Forum.

CONVENTION - At least 800 addicts attended our first regional convention last year. 600 was donated to the region. 3,000 was held back as a prudent reserve for this year's expected 11,000 budget for LRCNAII. They would like their prudent reserve to be increased. LRCNA currently follows WCCNA guidelines with regard to special interest meetings, that they are not planned in the interests of promoting unity. Some areas have asked that LRCNA reconsider their position next year.

FUNDRAISING AND ENTERTAINMENTS - Our F&E committee generated 450 from two events. There prudent reserve stands at 750 and they would like it to be increased. They have had problems finding an adequate venue. F&E are now addressing the problem and generating funds, having just organized a Valentines' Dance. Twenty percent of the proceeds were earmarked for European Study Group members' travel. Some areas are requesting F&E avoid venues where drugs are sold, and request more advance notice of events.

FINANCIAL STATUS

Areas donated 5910. As this works out to 139 per month less than it costs to run the LRSO, we remain in financial straits. In the past, this shortfall has been made up by contributions from F&E. Our prudent reserve does not currently cover a month's operating costs for the LRSO. Another fundraiser is planned. The convention committee hopes that some funds will be available prior to WSC.

OUR INTRA-REGIONAL REQUEST FOR SPONSORSHIP

A motion was passed at the September RSC requesting a travel subsidy from the WSC Admin Committee to attend the '91 WSC. Concern was expressed by members of the WSC Admin Committee that this would create an unwelcome precedent.

A motion was passed at the October LRSC to spend 15 on postage to send a letter to other regions, requesting financial support for travel costs. We asked whether sponsorship of travel costs to WSC '91 would be a violation of the 7th Tradition. It went to 47 regions, including the 35 RSC's who supported the `travel motion' last year.

In December we received a written response from the WSC Chair, saying other projects would have to be delayed if our request was met. Our request to the Southern California Region caused them concern; whatever assistance SCRSC would provide us would create a WSC shortfall and cause WSC-approved projects to be postponed or curtailed. We were asked to consider the needs of others as well as our own.

The BOT Chair faxed us with his perspective that we were seeking 'unearned gifts from outside sources,' and 'stepping outside commonly accepted practices of our service structure.' We were accused of omitting unspecified information and 'causing problems.'

Some ASCs are currently considering returning the donations we have received. The LRSC remains in favor of WSC attendance, and fundraising efforts are planned.

REGIONAL PARTICIPATION IN NATIONAL ASSEMBLIES

Our service structure is unique. All ASCs in the UK are eligible to participate in the UK Service Assembly (UKSA). The UKSA have a UKSAR who participates in the ECCNA. The ECCNA is also an ideal place for the LRSR to carry out the responsibility of providing two way communication with neighboring regions. As the UKSAR is not a WSC participant, the LRSR has something to offer in terms of world unity at ECCNA. LRSR participant, the LRSR has something to offer in terms of world unity at ECCNA. LRSR participation, however means a duplication in the channel of sharing London's group conscience.

As the Guide chapter on metropolitan services and national assemblies are incomplete, our growth in this area is timely. Sharing WSC strength, hope and experience may benefit us in our continued attempts to develop our NA service structure.

UKSO/LRSO RELATIONSHIP

Unlike other regions, LRSC does not receive any revenue from the sale of literature. Areas buy it directly from UKSO. This year a literature agreement was signed between WSO and UKSO. This agreement prohibits NA groups, areas and regions in the UK from using any vendors but UKSO.

At present, an ad hoc committee has been formed with both regional and UKSO participants involved. It is looking into ways in which the fellowship in the UK can best be served.

ANNUAL REPORT TO WSC

GREETINGS TO THE CONFERENCE!!!

REGIONAL FACTS AND FIGURES:

The Lone Star Region is composed of 14 areas which accommodate 208 groups hosting 890 meetings per week. Approximate size of Fellowship is 5,500. The RSC meets quarterly for 2 1/4 days with the location rotating between the areas. FRIDAY NIGHT: consists of JAC meeting and an RSC sponsored workshop, topic determined by ASRs with input from hosting area. SATURDAY: Regular RSC meeting with Subcommittee meeting all day. SUNDAY: RSC continues, subcommittees either continue to meet or host workshops and Learning days for local fellowship. New and old workshop topics this year included "NA and Taxes", "How to Reduce Our Costs and Increase our Donations", "The Guide to Service", "The Relationship Between the Regional Service Office BOD, RSC and Host Convention Committee".

AREA NEWS:

We welcomed one new Area into the Region this year, all others remained in tact. We have two functioning Area Service Offices in Houston and Ft. Worth. A couple of areas contributed (funded) bilingual members to the MSC Spanish Translation Ad Noc and bilingual meetings have begun in San Antonio (Esperanza Area). Meetings and interpretors for the Hearing Impaired are being sponsored and areas and groups are keeping literature stocked in Braile and audio tapes as well. Many Areas are beginning to incorporate the "Sharing Session" into their agendas with pleasing results.

SUBCOMMITTEE NEWS:

All Subcommittees are up and functioning. Their regular committee meetings are held quarterly during the RSC. Committee membership is comprised of the corresponding Area subcommittee chairs.

ACTIVITIES:

7 areas actively participated. Events sponsored by groups Areas and in the Region included bowling Tournaments, Skatling parties, Campouts, Haunted houses, Fishing trips, Beach parties and about a million dances.

POLICY:

Helped the Region and areas with policies and guidelines. Continues to help areas with workshops on Parlimentary Procedures, as well as the relationship between the RSC, RSO and HCC (host convention committee).

H & I:

Ten areas were consistantly represented this year. This committee has helped the areas coordinate in 64 treatment center meetings, 16 correctional facility meetings, 8 in Halfway Houses and one in Methadone Clinic. The committee hosted 3 learning days.

PI:

13 Areas participating this year which coordinated 5 RSC sponsored Learning Days. PI activities in the Region included 100 presentations and several exhibitions, 2000 pieces of literature mailed, 25,000 phone calls fielded and radio PSA in a number of Texas cities. Texts and tapes have been donated to libraries and a PSA ran on a deaf news program. Goals for the coming year are to improve our public image, develop information on speaking in schools and code all meeting schedules with additional needs info.

Literatures

Ten Areas represented. The committee reports working on their assignments, The Sponsor/Sponsoree Worksheet, and the Step Writing Guide. Their newest assignment is to review existing pieces of literature. The RSC Lit Committee held 2 workshops this year.

Spanish Translations Ad Hoca

This 10 member committee has worked very hard on an issue that affects us dearly because of our proximity to Mexico. The chair and some of the members were able to participate in the WSC sponsored workshops in Miami, New York, Texas and California. Since the bulk of our Ad Hoc committees work was completed, they disbanded this spring.

HCC:

Our Lone Star Region Convention (LSRCNAVI) will be held Easter weekend in Dallas. New ideas for this year include a late evening, main speaker, Friday night at 11:00 p.m. (for those arriving late or wanting an alternative to the dance), a playroom for kids of all ages with video games and pool tables, a comedy show, an auction and the introduction of the Security Committee which is a spin-off from Hotels, Hospitality and Transportation.

SUBJECT: 1991 Report to the WSC

The Mid-America Region continues to grow and stabilize its ability to offer recovery in Narcotics Anonymous. now 7 active areas, 60 groups, and 149 weekly meetings It's gratifying to know how accessible NA has become to addicts seeking recovery. Even in sparsely populated western Kansas, there is no location where a meeting is more than hour's drive, at least one evening a week. It hasn't always been Less than a dozen years ago there were only established meetings in the state of Kansas. Even with explosive growth there are still setbacks and needs to be area, representing six groups, has not been represented at our last three RSC meetings. One group, in cooperation with a utility company, is now having candlelight meetings. There many hospitals and institutions throughout the region that we are unable to carry the message to.

Our seventh regional convention, MARCNA VII, held in Great Bend, Ks., was attended by over 300 recovering addicts. Plans for MARCNA VIII, to be held in Wichita, Ks., April 5, 6 & 7, 1991, are going well and we're looking forward to another great celebration of recovery.

The 12th annual Fourth of July Campout was held at Clinton Lake, near Lawrence, Ks. As far as we know this is the longest running, continuous annual campout in the fellowship. The committee is working hard preparing for this years campout — the 13th annual.

Over the years the region has undertaken changes to improve the services that we provide to both to our areas and the WSC. In the past year we have entered into discussions on the responsibilities of trusted servants, purposes and projects of sub-committees, and the time and funds that these sub-committees have available to them. These discussions seem always to focus on how our resources are best used to support the continuing growth of Narcotics Anonymous; both at home and in developing NA communities. We have also begun to look at how our funds are provided (the "basket" vs. "fund raisers") and how much money we spend within the region versus how much we pass on to the WSC.

The region hosted a multi-regional workshop on "A Guide to Service in Narcotics Anonymous". We appreciate the support and participation of surrounding regions and the WSC. It was well attended (45 participants on Saturday afternoon). Some participants traveled from as far away as Detroit, South Dakota and Wisconsin. While the region realizes that the Concepts and

service structure as defined in the "Guide" are, as yet, not acceptable, we support the continuing efforts of the WSC Ad Hoc Committee on NA Service.

The Public Information Committee of the Western Kansas Area recently participated in a television interview with a TV station whose broadcasts are aired in southwest Kansas, southeast Colorado and the Oklahoma panhandle. The area committee stayed in close contact with the regional and WSC PI Committees while preparing for the interview and an enlightening message about Narcotics Anonymous was broadcast.

The H&I Committee undertook the project of supplying a Basic Text to each county jail within the region. This project includes the continued supply of Basic Texts to these facilities on an "as needed" basis.

The H&I and PI committees, in conjunction with surrounding regions, are making plans to commence an annual multi-regional H&I/PI workshop. They intend to establish an ongoing workshop to be rotated from region to region each year. The project requires both financial and member support from several regions.

While the illicit Basic Text seems to have embroiled the Fellowship in controversy, the issue has been dealt with calmly and maturely in the Mid-America Region. We realize that no edition of the Basic Text will ever be written exactly as any individual member, group, area or region would have it written. With this awareness comes the understanding that acceptance is the basis of unity, for the message in our Basic Text must express unity. Those who have spoken to the issue see this insistent argument as a great distraction of our resources: Resources that could be far better used to assist in the growth of our Fellowship. As to the legal action taken by our BOD, there has been only one member who voiced the opinion that this should not have been done under any circumstances. Other members accept the decisions arrived at by our service structure and believe that the BOD was right in taking action to try to preserve what they feel is a unified message of Narcotics Anonymous. In answer to the debate surrounding the essays on the Fourth and Ninth Traditions: We believe that any body which, made up of members of our Fellowship, undertakes to carry the message of NA, must be an integral part of Narcotics Anonymous, so as to be guided by and answerable to the Fellowship. During all these discussions, the belief has been expressed that these problems will be resolved by an application of our spiritual principles. God hasn't brought us this far to drop kick us out of bounds.

We look forward to participating in the this year's conference; to practice acceptance and gain unity. We extend our love and support to all our fellow members, worldwide.

Greetings to the fellowship from the New Jersey Region of Narcotics Anonymous. We our grateful for being clean today and for having this opportunity and privilege in presenting our annual report to the 1991 WSC.

In January the New Jersey Region has carried the message of recovery to addicts in New Jersey for 6 years. After a year of much struggle during the formation of the Northern New Jersey Region, this past year has been one of positive rebuilding, reorganizing and encouraging members to get back involved in our service structure. I'm happy to announce that we have formed two new Areas bringing our total up to 10, which provide services for up to 250 Groups and Meetings. And currently all our sub-committee positions are filled.

Our <u>CONVENTION COMMITTEE</u> for this years convention was elected on the last day of last year convention. Utilizing the high spirit, enthusiasm and lack of sleep most positions were able to be filled. It worked, but we think some chairs are still wondering why they volunteered and how they were seated. Sounds like the NA railroad to me.... The theme of this year's convention is "Continue the Miracle" and is being held on Memorial Day weekend May 24, 25 and 26 at the Ramada Renaissance, 3 Tower Center Blvd., East Brunswick, NJ. Of course preregistration is encouraged and more information can be obtained by contacting Christine K. (908) 396-9809.

PUBLIC INFORMATION in the Region is mostly being carried out at the Area level. Our P.I. chair is currently contacting Area P.I. chairs to formalize a regional committee to organize combined Area workshops, learning days and speaking commitments.

Our <u>HELPLINE</u> received 16,772 calls in the year 1990 at a cost of \$11,367.30. This cost is shared equally between both the New Jersey and Northern New Jersey Regions under our Shared Service Agreement.

The <u>NEW JERSEY STATEWIDE MEETING DIRECTORY</u> listing all of the meetings in both New Jersey Regions is also a shared service between both Regions. There are about 500 groups and meetings listed in the new Winter/Spring printing of 42,000 copies. At the present we update and reprint three times a year.

Our <u>POLICY COMMITTEE</u> is busy doing the paper work to incorporate the Region as a nonprofit organization so that we can now cover our tax liabilities pertaining to the transfering of funds between the Region and the Convention Corporation. Our current policy is also being updated and reconciled into a revised edition of regional policy including committee guidelines and corporate by-laws.

The <u>LITERATURE COMMITTEE</u> has worked hard this past year in reviving a resentful, nentrusting Area literature committees and members into currently 6 skeptical but willing to be productive literature committees ready to be apart of our literature process again. They have pre-reviewed and inputed the first two traditions and look forward to reviewing both the steps and the traditions projects. Others current and future projects are reviewing

and inputing Rolationships in Recovery, setting up review workshops for the Guide to Service and 12 Concepts, revising old IP's, developing a new IP "The Spirit of Giving" to replace "Hey Whats the Basket For" and developing a literature review newsletter.

Nicky Newcomer, while noticing everyone getting high around him, remains clean keeping his memory green and finding gratitude in the pages of our regional <u>NEWSLETTER</u> called <u>SANITY</u>. The Newsletter is about to enter its 5th year with subscriptions holding at about 205.

The <u>HOSPITALS AND INSTITUTIONS COMMITTER</u> at the present has all 10 Area committees committed to carring the message inside to more than 70 Institutions. The committee is looking into developing an H&I mobil panel unit to be on call to travel around the Region.

Our financial security is a major concern today. It seems the fund flow from the Groups to the Area to the Region has almost ceased to exist and our current services are threatened. We are hoping that by reevaluating our budget and reinforcing the importance of the 7th tradition to the Groups and members well be able to pull ourselves out of this crunch and continue the high level of services we've offered to date.

At our January Regional Conference we passed the following motion: DO YOU WANT OUR REGION TO ACTIVELY PARTICIPATE IN THE CONTINUING EFFORTS OF THE WORKSHOP OF REGIONS, NOW CALLED THE EASTERN MULTI-REGIONAL ASSEMBLY, BY BEING A VOTING MEMBER. intent: TO FORMALLY PROVIDE A SETTING WITHIN THE EXISTING SERVICE STRUCTURE TO DEAL WITH LOCAL MULTI-REGIONAL ISSUES. For about a year and a half we have been actively involved with this service workshop and have found it to be very informative and helpful, lending much support to the surrounding Regions. We are hoping that more Eastern Regions get back involved after "coming to believe" that we are not an outside service structure trying to tear down World Service, but a positive conscience working within the structure.

In closing we'd like to thank the Northern New Jersey Region for their continuing support in carrying out our Shared Service Agreement. We'd also like to thank all the Areas, groups and of course all the recovering addicts that make up the New Jersey Region, for with their support, concerns and actions the message, that recovery from the disease of addiction is even possible here in New Jersey, is a reality today and is reaching the addicts who still suffer inside and outside of the fellowship of Narcotics Anonymous.

This seems like a very short year but much has happened and our fellowship has grown. We have added a new area. The El Paso Area has joined our region, subsequently, the addicts we represent has grown fully by one third. I was recently in El Paso to present a seminar on the CAR and was proud and pleased by the enthusiasm and concern shown by their members.

One of the concerns presented which coincides with an old concern throughout the New Mexico Region is the difficulty we are having with Spanish translations of literature. There is a border specific dialect and vernacular which is vastly different from other dialects and is complicated by the fact that few in our fellowship who speak it are able to read Spanish. We've grown up speaking the language in our homes but the school system only taught English or Castillano Espanol. We are searching for possible answers to our dilemma. A suggestion is to produce a border dialect tape of the readings from the white book which we can submit to the translation committee for approval for local use in Spanish speaking meetings. We don't see our problem that much different from those needing American Sign or audio cassette translations. We invite your suggestions and input on the problem.

We also are anxious to hear the discussion at the conference concerning the world service sections of the proposed *Guide to Service* and how the American fellowship can effectively follow the lead of all the other nations and form a U.S. national conference which enhances our participation with the world body and eliminates the continued taking of valuable world fellowship time during the conference to discuss issues which are clearly U.S. in nature, and we are most pleased, especially after last year's discussions on the floor, at the serious attempt being made to conduct business in a more appropriate fashion by proposing a combined budget. Additionally, we are most grateful that the federal judge assigned to our suit is such a wise man and a wise ass at the same time. I believe we got the point of his sermon.

Your are all invited to join us in Las Cruces, July 21-23 for our third New Mexico Regional Convention. Thank you for your time.

1990-91 has seen little growth in the fellowship. Meetings and numbers have stabilised and appear to have consolidated with fewer starting and stopping. We see this as a good sign and believe that the groups as well as the members are beginning to mature. Hopefully this will provide a basis to carry out more H and I and P.I. work.

We still find committment and enthusiasm towards services wanes. It is an opportunity for World Fellowship, experience and celebration that a number of us won't be missing out on.

We unfortunately won't be represented at this years conference. Funds are low and the Region has decided to concentrate on internal priorities. We are discussing the possibility of special fund-raising to enable us to send a representative to next years conference. It really sounds as if infoads are being made at world level to develope a conference which will benefit the entire fellowship. We do feel isolated by distance here. Especially with deadlines for returning information literature reviews, reports etc. While most of the time the postal service is efficient we are very pleased to see a Fax number for more urgent matters.

NORTHERN CALIFORNIA REGIONS ANNUAL REPORT

4/20/91

To all our fellow addicts in recovery around the world, GREETINGS! As another year passes, we keep learning and making changes. We'd like to share them with you.

Our region began the year with 15 Areas serving 696 meetings; we now have 17 Areas that serve around 850 meetings per week. One Area, that encompassed 12 cities has divided into three ASCs. They are now known as the East Bay North, East Bay Central and Mission Peak Areas. Currently, they are sharing the already established Sub-Committees until each of the newly formed ASCs can support their own. This division was planned to insure that there would be no "break" in services; to encourage others to share in the rewards of doing service, and in the hopes that services will improve as they become more localized and have more people involved in serving NA.

One of our ASCs has seen a return of approximately 15 groups that had joined the Sierra Sage Region. As a result, the eastern border of our Region has expanded to include all of Lasen and Plumas counties and the western portions of Nevada county.

Our RSC has made several changes. One apparent problem was the location of the RSC meeting. Options discussed were: having the RSC geographically centered, rotating the RSC around the Region, or keeping the RSC within the most densely populated section of our Region. We resolved the problem by moving our RSC meeting to a place that was close to the metropolitan center, but where it would also equalize the travel time for our members traveling from our northern and southern borders.

Another change was that voting privileges were granted to all members of our RSC. The Admin. Committee, RSR, Alternate RSR, and Sub-Committee chairs now have a vote. This recent change deems ALL members of the RSC equally accountable for the actions and the functioning of the RSC; whereas the ASRs alone, have the right to direct the focus of the RSC. This issue has plagued the RSC since the change in the language in the TWGSS concerning voting. Over half of our ASCs also function in this manner.

Our RSC Admin. Committee now meets each month just prior to the RSC meeting. The purpose of this is to discuss necessary changes in the agenda, to discuss proposals for improvements of the RSC meeting, and to iron out differences between Admin. members, thereby eliminating the RSC as a place for those differences to be aired. The affect this has had on the RSC is a healthy one. The Admin. Committee have learned to work well together and demonstrate unified leadership. RSC business is conducted in a more refined manner and our meetings are shorter most of the time.

We are planning to hold a Conference Report - Regional Assembly in May. The purpose of this event will be to provide current information concerning the WSC, and to provide a forum for any NA member (but specifically GSRs) to ask questions and get answers. This is being announced at our CAR workshops. At the same time we are suggesting that if this event is well attended, we may try to have two Regional assemblies prior to next years WSC. This will lessen the diversion of ASCs from "service" and allow all Groups who want to share equally in the Regions voice at the Conference. Groups will have a direct link to the WSC through their GSR. So far, we are seeing a very positive response to this suggestion, and, only time will tell.

A notable difference in the focus of the RSC this year concerns our budget. The majority of our financial resources were budgeted for actual "services" provided by the RSC though the Regional H & I and P.I. Sub-Committees.

Last year we held a regional workshop on the 12 Concepts for Service; as a follow up, this year we hosted a multi-regional workshop on "The Guide to Service". The other two Regions who participated were Sierra Sage and California Mid-State.

Our Region was informed that the WSC may change the format of the Conference Agenda Report (no longer including Regional motions). In spite of this forewarning, none of our ASCs expressed much concern about the possible changes of the WSC or the CAR.

Last year we reported that one of our ASCs formed an Ad-Hoc Committee whose purpose was to look into the benefits and draw-backs of forming a new Region. One of the factors was the burden of travel; it takes around 9 hours to travel from end to end, and 4 hours to cross it. Another factor was the diversity of the addicts our Region serves, and that their needs vary widely. Their findings, however, were that a Regional division would not be feasible at this time.

Our Regional Literature Review Sub-Committee folded this year. The main reason was frustration with the constant changes in assignments given to them by WSC Literature Committee. Seeing no indication that assignments and/or focus of input desired wouldn't be altered again, they saw little value in beginning another project.

Our Regional Activities Sub-Committee also folded, mainly due to lack of support. Their purpose was to provide a calendar of all activities Region wide.

Last year the RSC granted its Policy Sub-Committee the freedom to address issues that were not referred to them, provided they gave preference to RSC referrals. At first this trust seemed promising. At times, the Policy Committee was used as an avenue to re-introduce motions that had repeatedly failed on the floor of the RSC.

The RSC addressed the pros and cons of a "standing" Policy Committee. The RSC decided to disband the Policy Sub-Committee, and to create an Ad-Hoc when needed.

During the last year, our Public Information Sub-Committee has done presentations at four National Conventions that were non-N.A. events and has begun to assist Areas to put on "community meetings". They have an audio cassette library now that consists of around 50 tapes to assist Area PI committees. The PI committee attempted to have a separate phoneline sub-committee. After a few months of research, the PI members found that this divided and weakened their efforts. The internal decisions of those committees were to re-unite their efforts, and focus on phone-lines quarterly.

We have 187 H&I meetings, region wide. The committee has improved communications with the RSC by giving the ASRs more information about the activities, literature dispersement etc. They have also been working to improve their communications with State Corrections agencies and establish a better working relationship with them.

The RSO purchases around \$50,000.00 worth of inventory every other month, avails insurance policies for ASC and/or RSC functions, and handles our convention funds. Due to the amount of attention the WSO has received over this last year, there has also been an increasing interest in the relationship between our own RSC and RSO. We will be watching closely how the WSO and WSC re-align their affiliation. We hope to learn how to enhance the coalescence of our RSC and the RSO.

Just as our Region has grown so has our Convention; but we still have Areas put on the Convention for the Region. Each year some of the Convention sub-committees fold or are reduced to one or two people doing all the work. This creates problems with accountability, burn-out, and quality of work. The NCRCAC Committee is searching for a better method of soliciting assistance to put on the Convention. It may be time to recognize the NCRCAC as a Regional Committee and bear the burden ourselves.

Three of our Areas have experienced much disunity over the issues surrounding the illicit Basic Text. Individuals have been harassed, have been removed from office or have resigned due to the strain. Some of our meetings have folded, others have been removed from schedules. The integrity of many individuals, of the NA service structure, and of the Fellowship as a whole, has suffered for no apparent gain.

Much of our service efforts were diverted to supplying accurate information and answering questions, simply to hold our Fellowship together. It has taken concerted of effort by the members of those Areas and those serving the RSC, to restore faith and trust in those serving our Fellowship at ANY LEVEL.

This controversy has cost our Fellowship much: effort; that could have been spent "carrying the message", unity; that would have encouraged more of our members to serve NA, money; that could have meant more services and literature for our members, both at home and around the world, and harmony; that would have been attractive to those who came to NA for help, understanding, and a chance to recover.

Our Region is asking itself two fundamental and important questions: "Do WE, as a Fellowship, have the right to say WHO WE ARE or ARE NOT?" & "If so, should our service committees limit their services only to those entities (Meetings, Groups, or Areas) WE consider to be NA?" These issues are out for discussion Region wide.

Last years Regional Convention went well, approximately 6,500 people attended the saturday night main meeting. It also turned out to be a financial success. The net proceeds from the NCCNA XII were \$27,464.00. The "seed" money (\$20,000.00) for our annual convention is held in a fiduciary capacity by our RSO.

This years convention --- NCCNA XIII "Never Alone" March 7th, 3th, 9th, & 10th, in Monterey, CA, at the Doubletree and Sheraton Hotel.

Our Regional donation to the WSC this year (1/90 through 12/90) was \$20,783.30

As of this writing we are also incorporating ourselves so that we are operating out of a legally sound and safe position.

As we enter the conference this year we bring a more mature and financially sound Region, dedicated towards carrying the message to all those we serve, to the best of our ability.

It is also our hope that we will soon see the Twelve Steps and Twelve Traditions in a form that can be approved.

The Narcotics Anonymous message is being carried within the Ohio Region loud and clear. We hope that this is a very pro life and upbeat year for our fellowship worldwide and the spirit of unity and love will continue to work in the lives of addicts everywhere.

OREGON "TOGETHER WE CAN" REGION 1991 ANNUAL REPORT

Greetings from Oregon and parts of Northern California! We have had another year of record growth, with more meetings than ever before, and more involvement throughout the fellowship.

Our Region made a few changes. We have 12 Areas at the present time, and 11 have been regularly represented at our quarterly RSC meetings. Southern Idaho officially split from our Region, and we continue to pick up bits of northern California through our Ore-Cal Area near Klamath Falls, OR. I understand that the Portland Area is considering a split in the near future due to their growth.

Our new name has provided some interesting controversy and is currently back to the groups for guidance and direction. We may have a different name by the time the WSC meets in April.

Our Region took a "straw poll" regarding the legal procedures instigated by the WSO Board over the illegal basic text issue. I'm happy to report that all 11 Areas represented were in complete support of our trusted servants. I was directed last fall to send this message to the Board, which I did. We discussed the matter again this January at our RSC, and the results were the same...unanimous support in favor of doing whatever it takes to protect the fellowship literature.

Our Regional Subcommittees have been busy. H & I held a Multi-Regional Learning Day in Silverton, OR. last March. As a result of Washington-Northern Idaho's participation in this event, many of our Area H & I Committees now have a new Orientation procedure. We have another Learning Day planned for this summer to be held somewhere in the Willamette Valley. I was sent to both the October quarterly and the WSC meeting in April last year and was elected as a voting member of the WSC H & I Committee.

The Regional Literature Committee has been doing an excellent job in reviewing and inputting pieces of literature for the WSC Literature Committee. They have a review workshop planned in march on "It Works: How and Why, steps 1 & 2". We were able to send our Chair, Emma W., to the quarterly meeting in October last year and she brought back much valuable information.

Phoneline is planning a Learning Day June 22 and 23rd in Salem. Last year's Phoneline Chair, Beverly W., was able to attend a Learning Day/Workshop in Phoenix.

P.I. will be working with Phoneline on the Learning Day. We also sent Mike L., who is a voting member of WSC P.I. to both the October quarterly and the WSC meeting in April last year.

Activities in our Region have been plentiful, but funds have been scarce. We hosted our annual Convention last year only a few months prior to the World Convention which was held in Portland. Our Convention just about broke even, which held our Regional budget to bare bones. We decided to forego having a convention this year and will really put some effort into planning a successful convention in 1992. Last year saw many addicts with limited finances and energy due to so many happenings.

We have a motion under consideration to extend the term of our RSR and RSR alternate. We currently have one year terms for each.

We have an Ad Hoc Committee researching setting up some Conference and Convention guidelines for our Region.

We are still looking into the possibility of a 1-800 number but it may be too costly due to having several area codes.

Our Parliamentarian is working on putting together Regional "job descriptions" along with a packet of by-laws and other pertinent information to be passed out to newly elected officers and subcommittee chairs. We hope this will offer some guidance and continuity to our committees.

In response to a letter directed to one of our Areas regarding our fundraising activities, we requested input from the Board of Trustees regarding the appropriateness of certain fundraising functions. The response we received was recently distributed to all ASR's to be discussed within their Areas and at their groups. We appreciate the input from the Trustees and hope it will serve as a springboard for much needed discussion.

We'd like to thank all of you who were able to share you recovery with us in Portland last year, and welcome you to "keep coming back" ...we need you and your support.

To be approuved 8 printed is the translation of IP#7 8 IP#2. To be revised ,approuved 8 printed is IP#10 8 IP#23. To be translated, revised, approuved 8 printed is booklets THE GROUP 8 BEHIND THE WALLS.

The 4 steps process for seeing a english IP to a french accepted translation IP is a very long process and demand a lot of dedication from members on that commettee and with GOO help things will be done in the right time frame.

PUBLIC INFORMATION:

Is more of a resources commettee then a directive commettee because the areas subcommettee are doing a wonderfull work and are meeting once a month with the regional chair to exchange exprience, strengh and growth with each other, so that the work is not duplicated and that the message carryed trought PI is the same troughout the region.

H & I:

Even if there as not been regional representation in the last year a tremendus effort is being done by individuals members who have their hearts in H & I to coordinate support to areas by meeting once every two months and a report is than made at the regional level.

HELP LINE:

No one as filled that position in the past year but the work is being done by those involved at the area level where a help-line exist and from the looks of it, a lot of newcomer are comming to a meeting that was directed from a help-line volunters.

N.A. NEWSLETTERS:

A newly formed commettee in last november with now 7 members teamed up to put out the first edition for april it will be made up of personal stories, information, joke, illustration and a lot more. We are looking foward to that even.

1991 ANNUAL REPORT TO THE WSC

Greetings from the dynamic, innovative and relentless San Diego/Imperial Region. We represent the southern most two counties of the State of California as well as Baja California, Mexico, and serve a population of 2.5 million (on the U.S. side of the border).

We have enjoyed another year of growth and maturity. currently have 277 groups in our Region, divided into seven Areas. The largest of these, the Central Area, serving most of the City of San Diego, has 90 Groups. Geographically the smallest, the Beach Area serves the beach communities of San Diego and has 24 Groups (including our oldest Group in continuous existence, Beryl Street). The United East County serves the metropolitan communities East of San Diego (including La Mesa, El Cajon, Lemon Grove and Santee) as well as a large rural area stretching to the Imperial County line and has 41 Groups. The South Bay Area serves the communities between San Diego and the Mexican border (including the cities of Chula Vista, National City and Coronado) and has 39 Groups. The geographically largest is the Back Country Area consisting of the mostly rural northeastern section of San Diago County as well as the entirety of Imperial County (pop. 109,000) and consists of 19 Groups. The North County Area serves the inland valley encompassing the cities of Poway, Ramona, Escondido and Fallbrook. During this last year, the North Country Area birthed our new North Coast Area. The North Coast Area serves the beach front cities from Del Mar to Oceanside including Camp Pendleton and Vista.

While California may be in a drought, this has been a water-shed year for our RSO. The I.R.S. granted our RSO tax exempt status and refunded over \$6,000 in paid taxes with interest. This was truly a relief and also allowed us to finally go forward with previously voted-on merchandising efforts. Our RSO was able to lease a room next door to the office and in December opened The Store. In addition to individual, Group and Area literature sales; The Store also has shirts and other N.A. merchandise. So far, The Store has been self supporting

Our P.I. committees continued to place Basic Texts into public libraries in our Region. Speaking engagements continue to reach new audiences. A major P.I. effort each year is the San

Diego County Fair which runs 20 days. Due to our previous success in staffing a booth day and evening - this year we were given a booth for all of the days of this year's fair. In Oceanside we hope to air a radio announcement. In El Centro, a TV spot will soon be broadcast. The radio and TV stations have agreed - now we are working out arrangements with Area P.I. committees in adjoining regions. In conjunction with the WSO and WSCPI, our Regional P.I. participated in the national Correctional Officers Convention last August. This year our Region looks forward to hosting the Western State P.I. Learning Days. The theme this year is "Phones & P.I.- The Vital Link."

The phone committee has been busier this year. We've had our 800 number for a little over a year now. In an average month we receive 2,373 phone calls. In reaching out beyond the local San Diego City calling zone we have made N.A. more accessible to anyone in our 619 area code. Most calls are for meeting information and having the 800 number has helped our diverse outlying areas. Our Region benefits from having only one area code. Our helpline is answered by volunteer addicts in recovery at the RSO. In San Diego the number is 584-1007. Elsewhere in the (619) area code - call 1-800-479-0062.

Our H&I committees are taking meetings into over 40 facilities. All seven Areas have active H&I committees. Our decentralization of H&I literature distribution is almost complete. Our Regional H&I coordinator publishes a quarterly newsletter which is both informative and engaging.

Our Activities committees continue to provide us with limitless entertainment from whale watching trips to the more mundane picnics and dances. The theatrical subcommittee presented their first play "The Committee" at our Regional Convention and on other occasions. Word is they're working in a new script.

Our Regional Convention did well for being four years at the same hotel. We had 1,700 registrations with about 2,000 attendees. This year we're in a brand new big hotel. We're going all out this year to attract our many friends from nearby Regions. Next year our convention will be in the big new San Diego Convention Center. Make your plans to visit San Diego this year on June 7, 8 and 9.

Outreach is a topic of growing interest in our Region. Five Areas have established Outreach committees. Functions range from outreach in the "pure" sense - across the desert to more Group services functions. Much of our current Group registration effort is being coordinated by our Area Outreach committees. The realm of Outreach is a topic of growing interest in the San Diego/Imperial Region.

Spanish literature is another often mentioned topic. In our Region there are a dozen Spanish speaking N.A. meetings north of the international border. At present there are 4 Groups in Baja California, Mexico - with over 18 meetings per week. There is one

group each in Ensenada, Rosarito Beach, Tijuana, and Mexicali. The Group in Tijuana is actually performing many if the functions of an ASC. Their liaison with the Public Health Department and Court system has resulted in steady referrals. Yes, meetings in Baja California now see court cards just as in the United States. The men if this Group carry an H&I panel into the local prison. The women of the Group have contacted the local women's detention facility and are making plans to carry a women's H&I panel there. Members of this Group's steering committee prioritize their needs as Spanish translations of (1) Basic Text, (2) the Group, Area and Region sections of the TWGSS, (3) Group Booklet, (4) portions of the H&I Handbook, and (5) posters of our N.A. 12 Steps and 12 Traditions. N.A. in Baja California is a strong fellowship; very unified with much caring for each other, and proudly N.A.

The birth of our North Coast Area was a process planned and voted on by all the groups of the parent North County Area. The Groups voted in a plan that allowed ASC Trusted Servants to choose in which ASC they would fulfill their term. The plan also specified division of funds yet left to each subcommittee how to divide commitments and assets. All subcommittees were encouraged to work together for 90 days. The plan was put together by an ad hoc committee that worked for 6 months compiling information on the parent Area. The plan included time for members to hold workshops and provided a contingency in case the baby Area floundered. The process has worked successfully and the new North Coast Area appears to be stabilizing quickly.

Overall, this has been a year of innovation and growth for San Diego/Imperial Region. Our RSC meets each month, though this year we voted to require the subcommittees to only attend every other month. The alternate month, with only ASR's, includes extensive open forum and general sharing on needs and issues. So far this new pattern is working well. At the time of this writing, our RSR position is vacant, pending upcoming elections. We are fortunate to have much experience to draw upon. Throughout our Region this has been a year for old-timers to return to service at Area and Regional levels. Our transitions are much smoother than was always the case.

We look forward to this upcoming WSC and a new conference year with the guidance of our loving Higher Power as expressed in our 2nd Tradition.

SUBJ: Annual Report to WSC

Greetings from the Show Me Region. May this report find all who read it enjoying the freedom of recovery. This year has again been one of growth for our region, not only in number and in size, but also in our willingness to confront serious issues that face both our region and fellowship as a whole. As with our personal recovery, progress has at times been frustrating and slow, but with the help of our Higher Power, our direction remains constant.

The Show Me Region is comprised of twelve areas, with 300 registered meetings and an estimated 1600 to 1800 members. SEMO, our newest area, which covers the southeastern portion or "boot heel" of Missouri, will be celebrating its first anniversary February 2. We are grateful for this new area, as it has provided much needed recovery to many suffering addicts, and has again brought to light the fruits of our fifth tradition.

Our areas are continuing to try new means of reaching the still suffering addict. Our Metro East Area in Illinois is sponsoring a meeting at a methadone clinic on a trial basis, as this has not been done before. We hope to learn and grow from this, and share our experience with others. An area in the southwestern portion of our state is trying an "800" number for their phone line. This is another first for our region, and they will be reporting on its benefits and drawbacks at our next business meeting. United Kansas City has a well functioning Area Service Office which receives ample support from its groups. All of our areas have been hard at work attempting to increase support within each area.

Lack of consistency in some of our local service structures continues to be an issue. As a region, we are focusing much of our efforts in being more accessible and available to these areas. In addition, we are allotting more time during our business meetings to discuss local service issues, in the hopes of drawing from each other's experience and strength.

Financial accountability and responsibility is yet another issue we are addressing. Our region and certain areas have been stolen from in the past, and after careful analysis, we addressed shortcomings in our region's requiring accountability from those who handle our monies. Our regional convention now operates under very stringent procedural guidelines in regards to money. Financial guidelines which are more comprehensive have been developed for our region, with partial implementation having taken place. We have a more in depth system of checks and balances, and realistic means of projecting needed funds for a twelve month period.

SMRCNA V was highly successful in all aspects. It was a true celebration of recovery, drawing addicts both from within our region and surrounding regions, with the messages of hope and freedom resounding throughout the weekend. Our second annual Campvention was equally successful, leading us back to the basics of one addict sharing with another in an atmosphere of love and fun. Two other area sponsored picnics, "High on Life" and "New Life", continue to be very successfull, ensuring that future area sponsored celebrations will happen. SMRCNA VI will be in Kansas City, MO, the second weekend in June, 1991. Campvention will be in central Missouri in September, 1991. "High on Life" and "New Life" dates have yet to be announced.

Our subcommittees continue to be active, although support fluctuates. An ad hoc subcommittee has been formed to review N.A.'s "Guide to Service." We will continue to educate ourselves on the material, along with reviewing it and submitting input.

Although support for the regional subcommittee is increasing, many areas do not have enough members who are able or willing to chair meetings. Regional H&I is distributing "Reaching Out" and "Behind the Walls" to those inmates who are in facilities without H&I meetings. Distribution will increase as requests increase. H&I has also discussed hosting area learning days.

Public Information hosted a learning day in May, which although was not as well attended as originally hoped, did prove to be quite valuable to those who attended. Many local P.I. projects continue within the region, including mass mailings to various counseling and treatment centers, phone line development, and local health fairs. A regional project currently under way is the researching of using billboards. Input sought from other regions is presently being reviewed.

Our Literature subcommittee is working on assignments from WSCLC and on two pamphlets that were created locally to submit to WSCLC.

Our RSO is doing well and has recently become self supporting. Office management has been restructured within the last four months, and this has proven to greatly enhanced general efficiency in operations. Changes allowing for more than one board member per area will hopefully increase the number of members in our Board of Directors.

While there are many areas in which we as a region hope to grow, we are grateful for the progress we have made, and confident that our resolve is strong to continue in serving the still suffering addict.

Report to the World Service Conference, 1991

The number of meetings in our region has not increased considerably but we have matured as a whole. Our four areas are composed of 51 recovery meetings. We are still seeking ways to carry the message to groups in rural and isolated areas of Northern Nevada and parts of California. We believe that some of these problems can be addressed with the Guide to Service.

As the Areas have grown in their manpower and experience, they have continued to provide Helpline services. Literature Distribution and the traditional celebrations of recovery: the High Sierra Blast (North Tahoe Basin Area); the Mountain High Camp out (South Shore Area): and our annual St. Valentines Day Dance (Carson/Minden Area). Besides these services the Areas have increasingly committed to providing the "hands on work" that only the Region has previously offered: H&I; PI; and Out Reach. The focus of the Regional committee has become more concentrated toward coordination and communication. Our goal for the next year is to become an education and training resource for all the areas.

Our regional convention "ONE PROMISE MANY GIFTS" is in the planning for July 19,20, and 21 1991 at the Peppermill hotel and casino. The Sierra Sage Regional Campout was not a big financial success but we did have a great time. The next campout will be in the summer of 1992, hope you can make it.

The Regional Service Committee has been mainly responsible for all Out Reach efforts, continues to he responsible for the H&I services delivered to our state prison system and has provided direction for the FI committee which has been turned over to one of our areas. The Literature Review Committee has disbanded due to the lack of assingments and the frustrations experienced while trying to produce work in our current literature structure.

On March 9, 1991 a delegation is going to Las Vegas in hopes to discuss specific proposals that may align Nevada's service structure with that of the proposed Guide to Service.

Currently the region is working on getting the areas under the corporate umbrella of our Regional Service office. Our first goal is to have all area helplines' financial transactions channeled through the RSO.

Our region has experienced a tremendous loss of manpower and experience but through the grace of GOD we maintain a stable cohesion. Through our growing pains we continue to support World Services financially and with manpower. As always, we would like to express our appreciation and gratitude to the WSC trusted servants and to everyone at the WSO for all of their work and support.

SOUTH FLORIDA/BAHAMAS REGIONAL SERVICE COMMITTEE

The South Florida/Bahamas Region is doing extremely well! Currently, we have 465 meetings per week and have all regional positions filled with dedicated and experienced trusted servants.

Over the past year, two new areas have formed and the Bahamas have decided to form their own region — more will be revealed! We are financially stable and look forward to opening a regional service office in the future. Since our formation, we have enjoyed relief from some of the unique geographical problems we had while part of a region the size of the state of Florida. We have centralized our RSC to a standard place and reduced it to a one day event. We have greatly reduced regional and area expenses by eliminating the need for extended travel and lodging. Most importantly, we are better able to address local issues and feel as though we know our neighbor areas.

At the same time, we have, met with the administrative committee from the Florida Region from which we sprang to foster unity and communication between our regions. Our RSC chairs stay in contact after our RSC's to provide accurate dissemination of information.

ASR REPORTS

- <u>Conch Republic (Florida Keys)</u> -- Having a problem with apathy in service at this time.
- North Dade Believe there is a need for a cheaper basic text.
- <u>Central Dade</u> There are many opinions on service basically divided among those who favor world service methods and those who favor more of a "grass roots" approach to service focused on the N.A. member.
- South Dade -- Have been hurt by the "Baby Blue" texts issue -- a lot of disunity on both sides of the issue has affected involvement in area services.
- South Broward -- There is a major problem of getting group support. Appears as if the "new generation" of N.A. members isn't getting involved in service or doesn't know how or has a negative attitude about service. Older members are getting burnt out but are continuing as no one is willing. Trying to develop unity by holding trusted servants workshops geared towards getting people involved.
- <u>Midcoast</u> Good sense of unity and a sense of service. Recent trusted servants workshop had great attendance and enthusiasm for service work.

Subcommittee Reports

Activities

This is a newly formed committee whose purpose is to "provide a bridge between the activities committees of local areas in order to allow for continuity of functions and also in assisting in the primary purpose of any activities committee -- "to promote unity in the fellowship." We have lots of support and enthusiastic encouragement.

Helpline

We are handling approximately 3000 calls a month among all the areas. Most run on an answering service beeper system. Two areas are trying voice mail box systems and are having some problems, but are cutting down on their bills. We are currently researching a regional 800 number helpline to cut down on costs.

Hospitals & Institutions

Being a part of the beginning of a new regional H&I subcommittee has been a wonderful and overwhelming experience. It has been gratifying to be a part of a growing enthusiasm for H&I work. We had a slow start but the formation of two new areas and H&I subcommittees has accelerated our growth. We are a well functioning committee with good participation. Our eight areas serve around 80 facilities with 140 meetings per week. We raise awareness for H&I efforts through gratitude dinners and learning days. Our committee benefits from a lot of experience, strength, and hope from members with area, regional and world H&I involvement.

Literature Review

We are currently working on a step working guide and have completed Step One so far. We will also be working on the steps and traditions. Due to the change in policies by the world service ad hoc committee on the Spanish translation of our Basic Text, our regional translation committee has disbanded.

Newsletter

We have a core of five people (one with desk top publishing!) working on our newsletter. Our name, "Together We can," speaks out to the unity of N.A. The newsletter is basically informational and useful to areas that don't have newsletters, as well as to H&I subcommittees and meetings which are highly encouraged to distribute those in their meeting. The newsletter is free of charge. It's goals will be to give a better understanding of what happens at the regional service level, will highlight world happenings and will include area reports. This will be a quarterly publication that will include: 2-3 articles on current news on services; regional committee updates involving their needs; how areas can help and what they do to help the areas. There will be a calendar of events for area, regional and worldwide activities, a cartoon/humor/poetry section, a step and tradition article and possibly a Spanish article. The first issue will be released in March at the Florida Spring Service break at N.A. and there will be 5000 copies with four sides in an 8 1/2" x 14" format. There will be an address and fax number by which to submit input. This is a very exciting and unifying effort!

Public Information

We have concentrated on planning the Florida Spring Service Break for N.A., FSSBNA ("Fizz-Bin-NA!") being held March 15-17 in Miami Beach. This conference will have workshops on the "World Conference Agenda, Beginners in Service, Twelve Traditions, Literature, Public Information, Hospitals & Institutions, The Group, Newsletter, Helpline, How to Run A Business Meeting, East Coast Conference, etc."

The most important focus is the number of workshops geared toward beginners in service — "Unless we provide addicts with information and experience concerning (group services), little of what we do concerning the so called "big issues" will have any meaning." Much of our focus will be on helping addicts serve groups by chairing meetings and business meetings, discussing group trusted servants, etc.

There will also be formats for members from a variety of regions and world services to exchange ideas and viewpoints on the direction of our service structure.

This year we have concentrated on supporting local Public Information events at the area level, assisting in various area learning days and trusted servants workshops. We have also attended conferences of the Florida Alcohol and Drug Association, the National Orthopsychiatric Association, and the National Youth Crime Prevention Organization, among others. It has been a busy, productive and rewarding year!!

This reports comes to you with love and recovery from the Southern California Region.

AREAS AND MEETINGS: At this time we have 563 meetings listed in our regional directory, in contrast to the 445 meetings listed last year. In an effort to serve the non-english speaking addict we have five (5) Spanish speaking meetings. We also have one (1) Persian speaking N.A. meeting.

We have three new areas bringing our total number of areas up to nineteen (19). Of our 19 areas, 17 of them are active at the regional level. A number of areas have begun offering meetings at non-traditional times (noon and late night). Most of the areas have begun publishing local directories. Many of the areas have been hosting unity days and service workshops. Two (2) areas have Outreach committees that send members to attend meetings requesting support. Challenges our areas and meetings face include difficulty maintaining a quorum in some areas; trying to maintain good taste at talent shows without one group imposing their values on another group; and trusted servants that attend other fellowships endorsing outside enterprises in their H&I, P.I., and Phonelines N.A. service commitments.

REGIONAL SERVICE OFFICE: Accomplishments in the last year include providing \$145,344.25 of literature (in contrast to \$144,810 last year) to our fellowship; our original special worker (Sharon) went on to greener pastures and our new special worker (Jackie) is helping us improve our computer system facilitating inventory control and accounting. We are in the process of expanding our non-profit status in a manner that would permit us to provide areas with insurance. One of our areas operates its own office.

HOSPITALS AND INSTITUTIONS COMMITTEE: Several years ago a decision was made in our region to create area H&I committees. The intent was to shift much of the responsibility for local H&I panel support to the areas; thus permitting the region to focus on serving the county, state and federal penal systems. This transition has been completed with all of our 19 areas having area supported H&I committees, serving an estimated 461 panels region wide (there were 363 monthly H&I meetings last year). Regional H&I currently serves in 12 Institutions (compared to 6 last year). Two of the regional institutional panels serve incarcerated HIV positive addicts. H&I also put on a successful regional workshop this year.

LITERATURE: The newsletter that we began publishing last year was a big success, but due to inconsistent funding, those involved in publishing the newsletter returned to area service where they are publishing a multi-area newsletter. We coordinated area literature committees reviewing and imputing "Restoring Relationships in Recovery", "Unity" and one new literature committee was given five (5) approved IP's to review. Our revised guidelines have been approved and we will now conduct quarterly regional literature review workshops. One of the primary services of Regional Literature was serving as a forum for area literature committees to address their common concerns, primarily relating to the sale and inventorying of N.A. literature. 16 of our 19 areas have literature committees; the remaining areas do not utilize a committee system for the distribution of literature. 6 areas produce newsletters and 13 areas are involved in literature review.

PUBLIC INFORMATION COMMITTEE: Our P.I. committee continues to provide quarterly workshops. We rotate the area which hosts the workshop which has facilitated increased support and enthusiasm. Regional P.I. also coordinates public service announcements, health fairs, radio talk shows, and P.I. panels. We are continuing our efforts at the exploration and development of a regional hotline. We purchased a P.I. Booth from the WSO and created a regional phoneline that gives Spanish speaking meeting information in Spanish. 13 of our areas have P.I. subcommittees and an additional 3 do some P.I. work. 14 of our areas have phonelines; those with no phonelines are working on getting information lines; those with information lines are upgrading to help lines or hotlines.

CONVENTION COMMITTEE: Our regional convention was a tremendous success with 2,775 registered and an estimated 4,000-4,500 in attendance. The committee is exploring expanding its prudent reserve to open up more competitive bidding (by allowing us to pay in advance rather than relying only upon merchants who are willing to be paid after the convention). Next years convention will be in Palm Springs; we are exploring the feasibility of a four (4) day convention with a golf tournament.

A group of Gay and Lesbian addicts in N.A. approached the region requesting that we support them in sponsoring a convention. Much controversy emerged regarding this, however after lengthy and numerous discussions our group conscience was to support this convention and the host committee in their efforts. The program is intended to be of special benefit to the Gay and Lesbian recovering addict, however all addicts are welcome to participate in a program of meetings, workshops, and/or other events in keeping with the steps, traditions and principles of N.A. It is hope that the "Spring Convention" will provide an opportunity to replace fear with acceptance, which can only strengthen unity within our Fellowship. We are seeking feedback from those with experience strength and hope in this area.

ACTIVITIES COMMITTEE: This year we had six (compared to four last year) regional activities: New Years Eve Meeting and Dance (over 1000 attending); A Meeting and Dance celebrating the World Service Conference (with speakers from all over the world); N.A. Birthday Meeting and Dance; an H&I Learning Day and Dance; a Guide to Service Workshop and Dance; and our annual campout was co-hosted again by the San Diego/Imperial Region. 16 of our areas have Activities or Entertainment Committees.

REGIONAL SUPPORT OF WORLD WIDE ACTIVITIES: Our region participated in the initial efforts made this year to translate our <u>BASIC TEXT</u> into Spanish. Despite the recent changes made with how the actual translation work will occur, a number of members from our region will remain involved with the project. Our region proudly hosted a weekend workshop on the <u>Guide to Service in N.A.</u> and as mentioned above our activities committee sponsored a meeting and dance that weekend. This year our region had five members participating in the Traditions Ad Hoc Committee. We also have local members involved in service on the following world committees: H&I, Literature, Policy and Tape Review.

TREASURER'S REPORT: This report covers the period from January 1990 through January 1991. Noteworthy is that 70% (the same as last year) of our region's income stems from area donations and 43% of our income (compared to 60% last year) was passed on up to the WSC. Specifically in 1990, we donated \$28,602.03 (compared to \$22,146.87 last year). Last year in an effort to increase the fund flow to the WSC, this region established a working prudent reserve of \$6,000; such was calculated based upon the anticipated demands of the working subcommittees in this RSC; all monies above the prudent reserve were donated to the WSC on a monthly basis. The increased fund flow resulted in under funding of regional services such as our regional newsletter and the provision of literature requested by our H&I Committee. To prevent this from recurring we have raised our prudent reserve to \$10.000 and have returned to quarterly WSC donations.

REPORT TO THE WORLD SERVICE CONFERENCE 1991

Southern Nevada has already adapted several concepts from "The Guide to Service." We have been communicating with the C.A.N. (California, Arizona, Nevada) Area in the South as well as the Sierra Sage Region in the North. Talk of a state wide region as suggested in the Guide continues. In fact, Southern Nevada has committed to meet regularly with the C.A.N. Area in the form of a joint committee.

At the area level, for the last year we have incorporated the sample rules of order from the Guide. As well as the sharing session which we call our group forum. Many groups in our area donate funds directly to the World Service Conference on a percentage basis.

On a sadder note, our newly formed Outreach Committee was disbanded due to a lack of support. Our Regional Literature Committee has become a Literature Distribution Committee and will review literature on an ad hoc basis if needed. Our RSR and RSR Alt. had the privilege of attending our first WSC Quarterly Workshop since our region was formed due to the close proximity (Van Nuys) which made it economically feasible for us.

REPORT TO THE WSC, FEBRUARY 28, 1991:

Growth:

There are now 297 groups holding 357 meetings per week in the Tri-State Region, an increase of 25% since last year. H&I meetings have increased 12% to 56. We now have 13 areas, up 2 from last year. Trying to get all our groups, trusted servants, and service committees registered and updated is a never-ending project; motion #15 in the Conference Agenda Report may provide some motivation.

Finances:

We are developing a unified budget for our RSC, RSO, and convention. All regional financial activity is reported to the IRS on a single tax form.

Some of our areas have begun to question their tax status, and look forward to more guidance from world services than is in last year's report "N.A. Banking and Taxes".

A few more of our groups and areas have begun to donate directly to world services. The region also recieves donations from a few groups, as well as the usual area donations. These direct contributions have not caused problems for our areas or region.

One of our areas, after many arguments around their activities finances, adopted a policy of holding only four activities per year, with any excess receipts over expenditures being donated either to the region or WSC. Another area adopted a policy of donating \$1 per group per week to the WSC.

The Tri-State is on schedule to meet our commitment to support the approved WSC budget. Our total donation to the WSC (groups, areas, region) will be over \$6800, a 94% increase over last year. Another way of looking at this figure is on a per-group basis: \$22.90 per group this year, an increase of 55% over last year's \$14.77. We continue to stress Tradition Seven, looking for more improvement in this area.

The largest single source of funds in the Tri-State is our annual convention. Markup on sales by our regional office is the next largest, followed by contributions.

Our largest expense is travel (if we don't consider literature purchases and convention expenses).

Services:

In December P.I. and H&I representatives from the Tri-State, Mid-Atlantic, and Philadelphia regions, along with the WSC H&I Vice-Chairperson, met with the Pennsylvania Bureau of Corrections Drug and Alcohol Treatment section to discuss coordination of our efforts. At the very least, this provided an excellent P.I. opportunity, and a forum to share H&I experience. Whether this meeting will bear fruit beyond that remains to be seen.

The Additional Needs Subcommittee has continued its efforts with additional needs, and the human service agencies that deal with them. In February the committee put on a workshop dealing with AIDS in recovery. Despite the controversial nature of this topic, and concerns expressed about its appropriateness and potential for tradition problems, the workshop went very well, with better attendance than many service workshops.

One area P.I. committee is cooperating with the courts, putting on an introductory N.A. meeting — kind of like an H&I meeting — once a week in the courthouse.

Other services in the Tri-State continue as usual.

Unity:

The unauthorized alteration, production and distribution of our Basic Text has been a distraction through most of the year. While only one individual in our region distributed any of these things, discussions of the issue continue to take up a lot of time.

We were able to facilitate many of our regional committee members' attendance at Arlington, the Guide to Service workshop in Columbus, and the Board of Trustees meeting/CAR workshop in Harrisburg. Some were disappointed at the amount of time we spent on issues seemingly unrelated to carrying the message, some were excited by the opportunity to participate, but all benefited just through the interaction with addicts from other places.

Whatever questions our members have about our service structure, the relationship seems to be one of trust and support — as long as accountability is maintained.

ANNUAL REPORT TO THE WSC

Hello to fellow members of Narcotics Anonymous:

Our region currently consists of 12 areas scattered across 3 states and 2 countries (Minnesota, North & South Dakota, and Winnipeg). Since our last report, the 12th area has spawned out of Southern MN and we welcomed *The Open Door of the Southeast Area* to our region, which consists mainly of Rochester groups located in the southeast corner of Minnesota. There are rumors of other areas emerging out of other existing areas. Where there was once only geographical boundaries there are now recovering addicts holding meetings, forming groups, and demonstrating willingness to organize and develop functional service bodies. This has provided for the improvement of localized service efforts in carrying the NA message and working with the rest of the region in the spirit of unity.

We remain geographically intact as a region but are undergoing planning stages of regional reformation. We have scheduled our first regional assembly for next March providing the opportunity for groups to have direct input on the contents and issues contained in the Conference Agenda Report. Also, at our next RSC, our Policy Committee and Public Information Committee will be meeting together to examine and discuss what role PI would have in the future. At our last RSC we decided to accept the Twelve Concepts for NA participated in the workshop at Kansas City and are becoming more familiar with the contents of the Guide.

We continue to encourage the areas and groups to maintain current information regarding group updates and new group registration as well as updating trusted servant rosters and subcommittee information. We utilized the printouts from the WSO Data Services to aid in this process. Each area was given the opportunity to review and update the information which was then forwarded to the world.

The Service Office continues to experience growing pains as it endeavors to provide members, groups, and areas a more readily available access to NA literature in a timely fashion. The inventory on hand has expanded allowing the customer the opportunity to view the materials they are purchasing. The Board of Directors is undergoing changes and are hoping to elect 3 board members at the next RSC. The

office coordinator and its staff are uniting in effort to provide a more efficient and expanded service.

Our 8th annual RCNA will be held in Sioux Falls, South Dakota at Augustana College on June 7-9, 1991. This years theme is *Dare to Dream!* Some of the activities will be Speakers, Workshops, Dance, Pool Party, Marathon Meeting, Banquet, and much more. This is our regions largest event. Greetings from the Volunteer Region! Narcotics Anonymous is alive and well in Tennessee, and we are growing and recovering. N.A. meetings are available to addicts in all of the major cities and towns of our region, and our message of recovery is slowly spreading to the smaller towns of our state. Addicts from Bristol to Memphis are finding recovery from the disease of addiction thru the Twelve Steps and Twelve Traditions of N.A.

The Volunteer Region consists of seven Area Service Committees from throughout the state. Our most recent addition is the Greater Nashville Area, which was born from a division of the Middle Tennessee Area. VRC IX will be held in Gatlingburg in the beautiful Smokey Mountains this Thanksgiving Day weekend, and is already shaping up to be great time.

We in the Volunteer Region would like to take this opportunity to express our continued support for our World Service boards and committees. We appreciate the selfless service that is performed by the many members of our fellowship both in the Conference, on the Board of Trustees, and at the World Service Office.

It has been a year of growth and increased unity in the Volunteer Region, and we are grateful to be a part of the W.S.C., and to be able to witness the growth of Narcotics Anonymous. We would also like to take this opportunity to welcome the new Regions to the W.S.C. this year.

Greetings from the Washington Northern Idaho Region. I hope this year's conference brings us all her eagerly ready to deal with the business of this conference. We are also looking forward to the new direction the conference is taking this year and hope we can all work together for the good of N.A. as a whole.

Our region is comprised of 496 meetings within the state of Washington and the northern tip of Idaho, with a couple of meetings on the Oregon border. We have had at least 70 new meetings started this past year, mostly on weekdays, averaging 12 new meetings per day.

Our region presently consists of 17 areas, 16 of which participate in the Regional Service Structure. We are working with one area that split from a small area to encourage them to resolve their differences and/or participate in the RSC. We are trying to encourage some groups of an area that folded some time ago to join other areas or reform their area. This past year we had one area fold and the group in that area joined another struggling area to form a new, stronger area. We also had two new areas start by splitting off from existing areas.

Because of geographical distances that many of our groups have to travel to participate in an ASC, we seem to be starting new areas on a regular basis and in some case these areas struggle for a short time, then fold and rejoin an existing area. Because of the large geographical boundaries of some areas and the fact that they are only supported by a small number of groups, holding ASC's and providing services of an ASC is a constant struggle. Areas that have a large number of meetings in a small geographical area seem to do better in providing N.A. services, but still have their ups and downs, struggling to remain consistent.

We just celebrated six years as a region, since our splitting up from the old Pacific Northwest Region, with a birthday party hosted by one of our new areas. We will also hold an annual convention. This year WNIRCNA #7 will be on April 26, 27, 28, 1991 in Kenewick, WA. We will also host the Pacific Northwest Convention N.A. #14 in the fall, somewhere between Seattle and Tacoma, WA. We will also be hosting an annual U.S./Canadian border. We also hosted a WSC Guide to Service in N.A. and workshops last fall in Seattle.

Our regional H & I and PI Committees hold annual Multi-Regional Learning Days and smaller workshops/learning days on a regular basis. The Literature Committee meets regularly to discuss World Lit. projects and area issues, but has not chosen to take on any projects as a Regional Committee because of time and travel constraints. They encourage area Literature Committees to take on these assignments.

Some of the problems that we are trying to resolve are what was perceived as a lack of communication, lack of responsible leadership and a lack of participation as a whole. We feel that communication between RSC's is essential as a staffing point.

Because of the long distances that members have to travel, holding regular workshops or lengthy discussions on issues of N.A. or of the WSC has been mostly left up to each area. In the future we hope to encourage more discussion and participation of issues of concern to NA as a whole, on a regional level.

As a final note, things seem to be on an up swing, with dedicated members continuing to do their best to serve this region. We also support members from this region that are members of the WSC; H & I; PI; and Literature, Tape and NA Ways Committees. Looking forward to seeing some familiar and new faces in April.





Geographically the current boundaries of the Free State Region are: Pennsylvania and Delaware to the north, Frederick Md. to the west, Washington D.C. and Central Md. to the south, and parts of the Eastern Shore of Md. and Southern Md.

Currently we are 6 areas. The following is a breakdown of ASC's listing current services and subcommittees:

Currently, the Free State Region consists of 331 NA groups with 108 H & I meetings. There are 3 help lines averaging 1,500 calls per month, one service center and newsletter. Many of our services in H & I, PI, Help Line and Special Events overlap among areas and the last few years have given rise to the "Quad Area" concept to coordinate these services. This in turn has evolved into the Free State Region. We now have regional subcommittees in PI, H & I, Special Events and Ad-hoc bid committee for the World Convention.

Our groups are studying a proposal for an Annual Regional GSR Assembly and will be making decision on this in February 1991. Also the Free State Region will be putting in a bid to host the 1994 World Convention at the new Convention Center at the beautiful inner harbor of Baltimore.

We have been asked to provide a brief history of the events that led to the formation of the Free State Region.

Brief History

The history of the growth and development of Narcotics Anonymous in the C/P Region has been very rapid. Two major metropolitan cities, Baltimore and Washington with their surrounding counties, formed the basic hub of this region. The drug wars, murders and killings on the streets is horrible and virtually unstoppable by society. We keep growing because we stand as an alternative way that works. Thousands are recovering, yet thousands more are out there participating in the insanity of addiction. In ever increasing efforts to make our message available the C/P Region grew to 16 areas with approximately 700 groups. It became harder and harder to adequately serve and communicate with this many areas. This eventually brought about a breakdwon that did not seem resolvable.

We believe and our experience bears out that the division of the C/P Region was necessary to better unify, strengthen and focus our service efforts. It was a natural progression that was happening though many of us could not see it as our eyes became clouded by divisive issues and disunity.

This was unfortunate for all of us, yet perhaps something bigger was happening guided by a power greater than ourselves and that it was simply time to move on, evolve and grow.

We want to thank our brothers and sisters of the C/P Region for their recommendation that we be granted a seat at this year's conference.

The formalities were simple and basic. Baltimore voted unanimously to withdraw from the C/P ASC in May 1990. Various regional transition ad-hoc committees were formed during the summer and in unity the first meeting of the Free State Region was held in Baltimore in September 1990.

There is a lot of enthusiasm and love today as we are working and serving together to extend our services and further the growth of NA in Maryland. There is a strong Narcotics Anonymous message of recovery in our rooms and we believe we are one step further in our journey to provide hope and a home to the still suffering addict.

CHAIRPERSON'S ANNUAL REPORT.

3rd February, 1991.

The previous year has seen considerable growth in the fellowship of N.A. in Bermuda in terms of members, meetings, and structure. During the previous year, more people have celebrated a year clean than ever before. At the start of the year, there were three regular N.A. meetings and one H.& I. meeting at Casemates prison. The Saturday meeting on the base, although it had started in 1988, had been neglected and was existing in a vacuum. Members of N.A. started to attend this meeting, which is currently run as an H.& I. meeting. In November, Michael R. started a fourth N.A. meeting on Thursdays at St. John's Church. In January, 1991, another H.& I. meeting was started at Casemates. There is now a meeting of one sort or another on six days out of seven. We have come a long way.

Perhaps the most important development for the long-term health and growth of N.A. has been the establishment of a properly functioning Area Service Committee. At the start of the year, the A.S.C. consisted of the three Group Service Representatives, Steve T., David D., and David G. The Committee was not registered with the World Service Office, and did not have any formal structure. During the year, the Bermuda Area was registered with the W.S.O. as an area acting as a region. More importantly, an ad hoc committee consisting of Steve T., Mike D., David D., Anne-Marie G., and David G. produced a set of Area Guidelines that was approved by the groups and accepted by the A.S.C. on the 29th October 1990.

The guidelines provided a framework not only for the operation of the A.S.C. but also for the very significant work of the Area

Subcommittees. At the start of the year, apart from the H.& I. Committee, these existed in name alone. We now have functioning subcommittees working in the areas of Entertainment, Public Information, Phoneline, and Literature. The Chairpersons of these committees are ex officio members of the A.S.C.

The Entertainment Committee came into being with a series of Bowling nights on Wednesdays in May and June. The success of these nights led to a beach party, a Halloween party, and a New Year's party. While the last party was perhaps overambitious, the Entertainment Committee has worked hard during the year under the leadership of Li J. and has done a great deal to bring the fellowship together.

The H.& I. Committee leadership has transferred from Steve T. to Sam D. The Committee is working at involving the inmates in the running of the meetings. The few regular attenders of H.& I. meetings have been giving considerable amounts of their time to support the three meetings.

The Public Information Committee has been meeting under Nikki R. They have been active in a number of areas, and are looking into the feasibility of getting ads broadcast on radio and television. We might see dramatic developments in this area during the coming year.

The Phoneline committee is run by Anne-Marie G. N.A. in Bermuda has its own phone and answering machine. There is a rota of volunteers to man the phone on evenings. Unfortunately, calls seem to have fallen off lately. No doubt they will pick up soon.

The Literature committee has changed over from David D. to

David G. There is a substantial stock on hand, and work is being done to establish reordering levels to ensure a constant supply of literature.

There was an ad hoc T-shirt committee consisting of Mike D, and Steve T. who produced an N.A. T-shirt which proved to be very popular. It is to be hoped that this will not be the last local N.A. T-shirt.

The Area made donations to the W.S.O. totalling \$1100 during the year. This represents the first donations made by N.A. in Bermuda.

Another first was the attendance of the World Convention by two local N.A. members, Steve T. and Mike D. They brought back T-shirts, stickers, and considerable enthusiasm.

It has been a big year for N.A. in Bermuda. I have enjoyed being Chairperson. Your support has made the job an easy one. I would like to thank in particular the Area Treasurer, David D., and the Area Secretary Steve T., whose prompt and detailed minutes have been exemplary. Thank you.

WORLD SERVICE CONFERENCE REPORT 1991

Hello America - Greetings from N.A. in Spain. It has been a good first year for our region. In this report I will list some of the progress made. I would also like to take the chance to explain to you all some of the issues involved in our attendance at this years Conference.

LOOKING INTO THE REGION

First things first. We have had a 70% growth of meetings since last year - from 14 to 25 - and a new area too, in Cadiz. So N.A. is alive and well here.

We have consolidated the Areas within the Region - holding regional meetings in Ibiza and Madrid. Both were well attended and the 6 monthly event is now hugely popular with us all. So much so that the Regional Committee has decided to meet in between these events to streamline our service work. We have adopted a cost equalization plan so that the more outlying Areas are able to participate. There is so much to do - so much to learn - it is hard to know where to start.

We are scheduled to form a P.I. subcommittee in February and hope to stage a P.I. learning day soon after. H. and I. work is starting with prison meetings in 3 Areas.

Our literature people are hard at it, as always, with trans lations — once again so much to do! We have started to translate some of the service manuals which are vital if our service work is to be effective. Spanish members still wait with baited breath to read the Basic Text.

N.A. is a step away from being fully re-registered here. It has taken several meetings with our lawyers to amend the old statutes we originally presented in Barcelona some years back. We are now happy with the new statutes and hope to have them filed in the spring. Thanks to W.S.O. for their help in this.

LOOKING OUT FROM THE REGION

Spanish members look forward to, and participate in, the European Conference and Convention (E.C.C.N.A.), which was held last year in Lisbon. The Region is contributing funds to the European Study Group (E.S.G.), an ad hoc committee accountable to E.C.C.N.A. Spain, like many other European Regions, feels the need to communicate with other Regions, and the E.S.G. was created to study the different possibilities for this communication within Europe.

We were delighted to hear of the International Development Forum - but we are unsure if we will be able to attend it - or the W.S.C. 1991.

We are a small Region. We do not have many funds. We want to participate in N.A. as a whole. However, we feel it would not be responsible to bankrupt the Region in order to send our R.S.R. to the W.S.C.

The inevitable question our members ask is - Why are smaller younger Regions outside the U.S. expected to pay 20 or 30 times more than some strong U.S. Regions to attend an N.A. event which is considered to be World Level, and which thus affects us all?

It is a hard question to answer.

Perhaps the solution is in Europe having its own service conference only - thus cutting itself off from the experienced U.S. Regions. But surely these are things we all need to talk about together.
